

SPECKMAN SURVEY

SURVEYOR'S DESCRIPTION

scale:

Being a part of the southwest quarter of Section 7, Town-6-South, Range-5-East, Washington Township, Auglaize County, Ohio, as evidenced by Official Record Volume 157, Page 269 and more particularly described as follows:

Commencing for reference at a monument box (found) at the southwest corner of the southwest quarter of Section 7, and the centerline of East Shelby road; thence, S 89 degrees 30' 00" E along the south line of the southwest quarter, and passing through the centerline intersection of State Route 29 and Clover Leaf Road, and continuing along the aforesaid south line and centerline of Clover Leaf Road, for a distance of 1994.01 feet to a railroad spike (found), said spike being the **POINT OF BEGINNING** for the tract herein described;

thence, N 02 degrees 05' 59" E (passing through a 5/8" re-rod found on the north right-of-way line of Clover Leaf Road at a distance of 20.01 feet) for a total distance of 229.27 feet to a 5/8" re-rod (found);

thence, S 89 degrees 29' 58" E for a distance of 95.00 feet to a 5/8" re-rod w/cap (set);

thence, S 02 degrees 05' 59" W (passing through a 5/8" re-rod w/cap set on the north right-of-way line of Clover Leaf Road at a distance of 209.26 feet) for a total distance of 229.27 feet to a cotton gin spindle (set) on the south line of the southwest quarter of Section 7 and the centerline of Clover Leaf Road;

thence, N 89 degrees 29' 58" W along the aforesaid south line and centerline, for a distance of 95.00 feet to the **POINT OF BEGINNING**, containing therein **0.500 acres**, of which 0.044 acres is road right-of-way. It is understood that this is an "add-on" tract, and does not meet the requirements for residential construction solely upon said tract. Prepared by James M.
