

## SURVEYOR'S DESCRIPTION

Being a part of Lot 56 of the Original Plat to the City of Wapakoneta, County of Auglaize and State of Ohio, as evidenced by Official Record Volume 459, Page 2059 and more particularly described as follows:

**BEGINNING** at a mag-nail (set in concrete) at the southwest corner of Lot 56;

thence, N 00 degrees 39' 09" E along the west line of Lot 56, for a distance of 74.63 feet to a 5/8" re-rod w/cap (found);

thence, S 24 degrees 21' 42" E for a distance of 36.00 feet to a 5/8" re-rod w/cap (set) at the northwest corner of that part of Lots 55 and 56 which is evidenced by Official Record Volume 298, Page 862;

thence, S 00 degrees 38' 37" W along the west line of the aforesaid parcel, for a distance of 41.83 feet to a 3/4" iron bar (found);


thence, N 90 degrees 00' 00" W along the south line of Lot 56 and the north right-of-way line of West Mechanic Street, for a distance of 15.23 feet to the **POINT OF BEGINNING**, containing therein 887 square feet.
