
Hines to McNary Survey 9.846 Acre Parcel

SURVEYOR'S DESCRIPTION FOR 9.846 ACRE PARCEL SPLIT

The following described tract of land is situated in the Southeast Quarter of Section 11, Pusheta Township, Town-6-South, Range-6-East, Auglaize County, State of Ohio, and is more particularly described as follows:

Commencing for reference at a Monument Box located at the Northeast Corner of the Southeast Quarter of said Section 11, Pusheta Township;

Thence with a bearing of S. 00° -45'-48" W. along the East Line of the Southeast Quarter of said Section 11, Pusheta Township, and the centerline of Brown Road, (Township Road #181), for a distance of 485.00 feet to a P.K. Nail/Shiner (found) and the PLACE OF BEGINNING:

Thence continuing with a bearing of S. 00° -45'-48" W. along the East Line of the Southeast Quarter of said Section 11, Pusheta Township, and the centerline of Brown Road, (Township Road #181), for a distance of 50.00 feet to a P.K. Nail/Shiner (found);

Thence with a bearing of N. $89^{\circ}-14'-12''$ W. for a distance of 481.50 feet to an Iron Pin (found), and passing thru an Iron Pin (found) for reference at 20.00 feet;

Thence with a bearing of $5.00^{\circ}-45'-48''$ W. for a distance of 410.67 feet to an Iron Pin (found);

Thence with a bearing of N. 74° -07'-36" W. for a distance of 146.66 feet to an Iron Pin (found);

Thence with a bearing of $5.00^{\circ}-45'-48''$ W. for a distance of 390.27 feet to an Iron Pin (found);

Thence with a bearing of S. 84° -35'-41'' E. for a distance of 135.09 feet to an Iron Pin (found);

Thence with a bearing of S. 79°-03'-57" E. for a distance of 496.24 feet to a P.K. Nail/Shiner (found), and passing thru an Iron Pin (found) for reference at a distance of 475.92 feet;

Thence with a bearing of S. 00° -45'-48" W. along the East Line of the Southeast Quarter of said Section 11, Pusheta Township, and the centerline of Brown Road, (Township Road #181), for a distance of 50.80 feet to a P.K. Nail/Shiner (found);

Thence with a bearing of N. 79° -03'-57" W. along the centerline of an open ditch for a distance of 502.80 feet to a Point;

Thence with a bearing of N. $84^{\circ}-35'-41''$ W. along the centerline of an open ditch for a distance of 496.42 feet to a Point;

Thence with a bearing of N. 00° -47'-14" E. for a distance of 833.10 feet to an Iron Pin (found);

Thence with a bearing of S. 89°-14'-12" E. for a distance of 989.34 feet to a P.K. Nail/Shiner (found), and passing thru an Iron Pin (found) for reference at a distance of 969.34 feet, said P.K. Nail/Shiner being the original PLACE OF BEGINNING.

Containing in all 9.846 Acres of land, of which, 0.064 Acre being previously dedicated for highway purposes. The above described tract of land is subject to all other legal easements, reservations, or restrictions, if any, upon said premises. Basis of Bearings used were from the Auglaize County Engineer's Global Positioning Survey.
