



SURVEYOR'S DESCRIPTION

scale:

Being a part of the northwest quarter of Section 36, Town-4-South, Range-6-East, Duchouquet Township, Auglaize County, Ohio, as evidenced by Official Record Volume 194, Page 806 and more particularly described as follows:

Commencing for reference at a monument box (found) at the centerline intersection of National Road and Mudsock Road; thence, S 00 degrees 18' 07" W along the centerline of Mudsock Road, for a distance of 716.50 feet to a mag-nail (set), said nail being the **POINT OF BEGINNING** for the parcel herein described;

thence, along the centerline of a creek with the following courses:

S 78 degrees 53' 48" E (passing through the east right-of-way line of Mudsock Road at a distance of 30.54 feet) for a total distance of 67.84 feet to a point;

S 38 degrees 59' 00" E for a distance of 26.90 feet to a point;

S 56 degrees 14' 57" E for a distance of 48.43 feet to a point;

N 61 degrees 42' 56" E for a distance of 22.21 feet to a point;

S 87 degrees 42' 34" E for a distance of 35.43 feet to a point;

S 09 degrees 51' 05" E for a distance of 35.71 feet to a point;

S 57 degrees 52' 07" E for a distance of 59.09 feet to a point;

thence, leaving the centerline of said creek bearing S 89 degrees 00' 02" W (passing through a 5/8" re-rod w/cap set for reference at a distance of 24.05 feet, and a 5/8" re-rod w/cap set on the east right-of-way line of Mudsock Road at a distance of 205.54 feet) for a total distance of 235.55 feet to a mag-nail (set) on the centerline of Mudsock Road;

thence, N 00 degrees 18' 07" E along the centerline of Mudsock Road, for a distance of 122.50 feet to the **POINT OF BEGINNING**, containing therein 0.393 acres, of which 0.082 acres is road right-of-way. Subject to all easements and right-of-way of record at the time of the recording of this instrument. It is further understood that this parcel is an "add-on" lot, and does not meet the requirements as a "stand alone" building lot. Prepared by James M.
