The PLACE OF BEGINNING is at an iron pin found at the Northwest corner of Lot No. 27 in the Georgetown Estates Subdivision, Phase 2;

Thence S.89°07'43"E. along the North line of Lot No. 27 and the South right-ofway line of Middle Street, a distance of 107.46 feet to an iron pin found;

Thence along a curve to the right, an arc distance of 23.85 feet, having a radius of 15.00 feet, the chord of which bears S.43°35'14"E. a distance of 21.41 feet to an iron pin found;

Thence S.01°57'16"W. along the East line of Lot No. 27, a distance of 59.65 feet to an iron pin set;

Thence N.88°05'08"W. along the projected common wall line of a duplex residence, a distance of 122.79 feet to an iron pin set;

Thence N.01°59'42"E. along the West line of Lot No. 27, a distance of 72.70 feet to the iron pin at the Northwest corner of Lot No. 27, which was the true PLACE OF BEGINNING.

Containing in all 9,011 square feet and being subject to all legal easements, restrictions and reservations, if any, of record or in use on said premises. Basis of bearing is per the Plat of the Georgetown Estates Subdivision, Phase 2 as recorded. This description is based on an actual field survey performed by John W. Thence N.01°59'42"E. along the West line of Lot No. 27, a distance of 45.50 feet to an iron pin set;

Thence S.88°05'08"E. along the projected common wall line of a duplex residence, a distance of 122.79 feet to an iron pin set;


Thence S.01°57'16"W. along the East line of Lot No. 27, a distance of 45.50 feet to an iron pin found;

Thence N.88°05'08"W. along the South line of Lot No. 27, a distance of 122.81 feet to the iron pin at the Southwest corner of Lot No. 27, which was the true PLACE OF BEGINNING.
