

N.W. Corner, S.E. Quarter, Section 1.



## SURVEYOR'S DESCRIPTION

The following described tract of land is part of the Southeast Quarter of Section 1, Town 5 South, Range 6 East, Duchouquet Township, Auglaize County, Ohio and is more particularly described as follows:

Commencing at a Monument Box found at the Northwest corner of the Southeast Quarter Section 1 and in the centerline of Township Road 196 (Freymuth Road); thence S.89°28'43"E. along the centerline of Township Road 193 and the North

line of the Southeast Quarter of said Section 1, a distance of 165.60 feet to a Mag Nail set, which is the PLACE OF BEGINNING for the tract of land herein described; thence continuing S.89°28'43"E. along the above described line, a distance of

217.80 feet to a Mag Nail set;
thence S.00°47'05"W. a distance of 200.00 feet to an iron pin set, passing thru an iron pin set for reference at 20.00 feet in the South right-of-way line of Township Road 196;

thence N.89°28'43"W., parallel to the centerline of Township Road 196, a distance

of 217.80 feet to an iron pin set;
thence N.00°47'05"E. a distance of 200.00 feet to the Mag nail, passing thru an iron pin set for reference at 180.00 feet in the South right-of-way line of Township Road 196, said Mag Nail was the true PLACE OF BEGINNING.

Containing in all 1.000 acres of which 0.100 acre has been dedicated for highway purposes.
