PARCEL 2 LEGAL DESCRIPTION

Being Part of Parcel #G22-036-002-00 as described in Volume 506, Page 2250 of the Auglaize County Official Record of Deeds. Situated in the NW ¼ of Section 36, T-5-S, R-5-E, Moulton Township, County of Auglaize, State of Ohio a tract of land bounded and described as follows:

Commencing at a #5 rebar found at the intersection of the west line of the NE ¼ of the NW ¼ of said Section 36 and the northerly Limited Access right-of-way line of U.S. Route 33, also being the POINT OF BEGINNING for the tract of land herein described. Said point being S 00°-59′-00″ W a distance of 1,324.85 feet from a wood corner post found at the northwest corner of said NE ¼ of the NW ¼ of Section 36;

Thence along said west line of the NE ¼ of the NW ¼, N 00°-59'-00" E a distance of 483.93 feet to a set #5 rebar;

thence S 87°-51'-25" E a distance of 540.59 feet to a set #5 rebar;

thence N 31°-03'-58" E a distance of 622.69 feet to a set mag nail in the centerline of Fox Ranch Road (TR 125A), passing a set #5 rebar at 602.15 feet marking the west right-of-way line of Fox Ranch Road (TR 125A);

thence along said centerline of Fox Ranch Road (TR 125A), S 45°-47'-15" E a distance of 41.08 feet to a set mag nail;

Commencing at a #5 rebar found at the intersection of the west line of the NE ¼ of the NW ¼ of said Section 36 and the northerly Limited Access right-of-way line of U.S. Route 33 (basis of bearing). Said point being S 00°-59'-00" W a distance of 1,324.85 feet from a wood corner post found at the northwest corner of said NE ¼ of the NW ¼ of Section 36;

Thence along said west line of the NE ¼ of the NW ¼, N 00°-59'-00" E a distance of 483.93 feet to a set #5 rebar, also being the POINT OF BEGINNING for the tract of land herein described;

Commencing at a #5 rebar found at the intersection of the west line of the NE ¼ of the NW ¼ of said Section 36 and the northerly Limited Access right-of-way line of U.S. Route 33. Said point being S 00°-59'-00" W a distance of 1,324.85 feet from a wood corner post found at the northwest corner of said NE ¼ of the NW ¼ of Section 36;

Thence along said northerly Limited Access right-of-way line of U.S. Route 33, S 87°-51'-25" E (basis of bearing) a distance of 1,327.45 feet to a concrete monument found, passing a #5 rebar found at 654.60 feet marking the southwest corner of a 5.439 acre tract. Said concrete monument located at Station 26+18 of the centerline of Fox Ranch Road (TR 125A);

thence along said centerline of Fox Ranch Road (TR 125A), N 00°-55'-25" E a distance of 352.20 feet to a mag nail found, also being the POINT OF BEGINNING for the tract of land herein described;
