## SURVEYOR'S DESCRIPTION

Being a part of the east one-half of Section 6, Town-6-South, Range-4-East, St. Marys Township, Auglaize County, Ohio and more particularly described as follows:

Commencing for reference at a Capped Re-rod (found) on the east line of the northeast quarter of Section 6 and the northeast corner of that parcel evidenced by Deed Volume 156, Page 593; thence, S 01 degree 34' 40" W along the east line of the aforesaid parcel, and the east line of the northeast quarter of Section 6 for a distance of 380.54 feet to the **POINT OF BEGINNING** for the tract herein described:

thence, continuing S·01 degree 34' 40" W along the aforesaid east line of the northeast quarter (passing through the east quarter corner of Section 6 at a distance of 54.47 feet) for a total distance of 155.85 feet to a cotton gin spindle (set) in the centerline of pavement of Edgewater Drive;

thence, N 81 degrees 50' 49" W along the centerline of pavement of Edgewater Drive, for a distance of 225.27 feet to a cotton gin spindle (set);

thence, N 02 degrees 03' 21" E for a distance of 510.61 feet to a 5/8" re-rod w/cap (set);

thence, S 88 degrees 25' 22" E for a distance of 69.18 feet to a Capped Re-rod (found);

thence, S 01 degree 34' 39" W for a distance of 230.00 feet to a Capped Re-rod (found);

thence, S 65 degrees 36' 21" E for a distance of 93.00 feet to a Capped Re-rod (found);

thence, S 08 degrees 41' 20" E for a distance of 99.99 feet to a Capped Re-rod (found);

thence, S 69 degrees 26' 24" E for a distance of 49.49 feet to the **POINT OF BEGINNING**, containing therein **1.648 acres**, of which 1.216 acres lies in the northeast quarter of Section 6 and 0.432 acres lies in the southeast quarter of Section 6 Subject to all easements and right-of-way of record at the time of the recording of this instrument.
