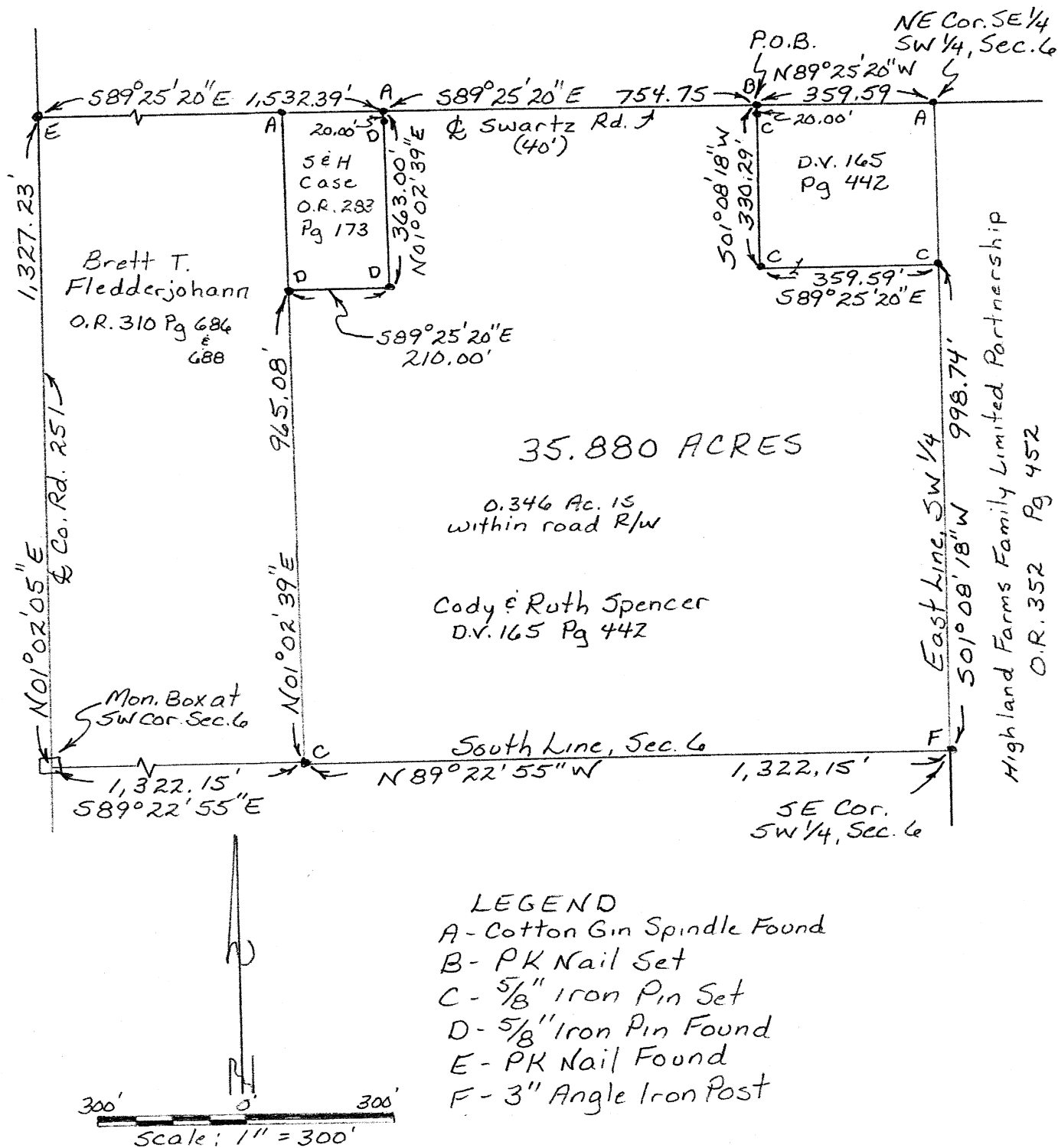

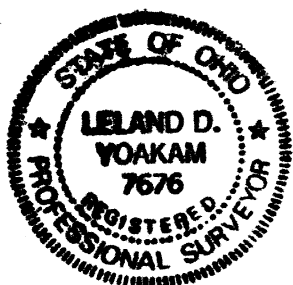

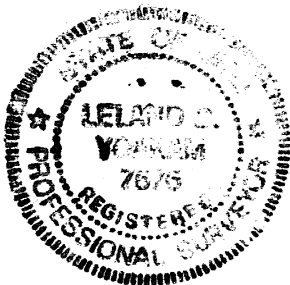

The following described parcel of land is situated in the Southwest Quarter of Section 6, Township 6 South, Range 8 East, Goshen Township, Auglaize County, Ohio and is more particularly described as follows:

Commencing at a cotton gin spindle (found), marking the Northeast Corner of the Southeast Quarter of the Southwest Quarter of Section 6, also being the centerline of Swartz Road;
thence with the centerline of Swartz Road, N 89° 25' 20" W, a distance of 359.59 feet to a P K nail (set) at the POINT OF BEGINNING for the parcel to be described;
thence S 01° 08' 18" W, a distance of 330.29 feet to a 5/8 inch iron pin (set), passing at 20.00 feet a 5/8 inch iron pin (set);
thence S 89° 25' 20" E, a distance of 359.59 feet to a 5/8 inch iron pin (set) in the East line of the Southwest Quarter of Section 6;
thence with said East line, S 01° 08' 18" W, a distance of 998.74 feet to a 3" angle iron post (found) at the Southeast Corner of the Southwest Quarter of Section 6;
thence with the South line of Section 6, N 89° 22' 55" W, a distance of 1,322.15 feet to a 5/8 inch iron pin (set);
thence N 01° 02' 39" E, a distance of 965.08 feet to a 5/8 inch iron pin (found) at the Southwest Corner of a 1.749 acre tract owned by Scott D. and Heather N. Case as described in O.R. 283, Pg. 173;
thence with the South line of said Case land, S 89° 25' 20" E, a distance of 210.00 feet to a 5/8 inch iron pin (found);
thence N 01° 02' 39" E, a distance of 363.00 feet to a cotton gin spindle (found) in the centerline of Swartz Road, passing at 343.00 feet a 5/8 inch iron pin (found);
thence with the centerline of Swartz Road, S 89° 25' 20" E, a distance of 754.75 feet to the POINT OF BEGINNING, containing 35.880 acres, more or less, subject to all legal highways and easements of record. This description is based on an actual field survey performed in September, 2005 and was prepared by Leland D. Yoakam L.S. No. 7676.
