

The following described parcel of land is situated in the Southwest Quarter and the Southeast Quarter of Section 5, Township 6 South, Range 8 East, Goshen Township, Auglaize County, Ohio and is more particularly described as follows:

Commencing at a monument box marking the Southwest Corner of Section 5, also being the intersection of the centerline of Goshen Road with the centerline of County Road 261;

thence with the centerline of County Road 261, N 01° 06' 40" E, a distance of 1,323.39 feet to a P K nail (found) at the intersection of the centerline of Swartz Road;

thence continuing with the centerline of County Road 261, N 01° 06' 40" E, a distance of 25.00 feet to a railroad spike (found) at the POINT OF BEGINNING for the parcel to be described;

thence continuing with said centerline N 01° 06' 40" E, a distance of 480.49 feet to a railroad spike (found);

thence S 89° 00' 28" E, a distance of 989.76 feet to a 5/8 inch iron pin (found), passing at 25.00 feet a 5/8 inch iron pin (found);

thence N 01° 07' 40" E, a distance of 821.87 feet to a 5/8 inch iron pin (set);

thence with the North line of the Southwest Quarter, S 89° 07' 16" E, a distance of 1,658.23 feet to a 5/8 inch iron pin (found) at the center of Section 5;

thence with the North line of the Southeast Quarter, S 88° 55' 20" E, a distance of 1,706.22 feet to a point in the centerline of Michinnippi Ditch, passing at 1671.22 feet a 5/8 inch iron pin (found); thence with the centerline of said ditch the following courses;

S 13° 47' 13" E, a distance of 200.32 feet;

S 47° 40' 37" W, a distance of 242.24 feet;

S 48° 07' 22" W, a distance of 259.61 feet;

S 41° 14' 35" W, a distance of 179.14 feet;

S 22° 29' 47" W, a distance of 139.30 feet;

S 12° 03' 15" E, a distance of 147.96 feet;

S 04° 57' 15" E, a distance of 207.27 feet;

S 08° 57' 17" W, a distance of 174.83 feet;

thence N 88° 57' 18" W, a distance of 1,257.55 feet to a 5/8 inch iron pin (found), passing at 35.00 feet a 5/8 inch iron pin (found);

thence N 89° 13' 58" W, a distance of 877.45 feet to a 1 inch iron pipe (found);

thence N 00° 47' 12" E, a distance of 229.85 feet to a 5/8 inch iron pin (set);

thence N 88° 59' 49" W, a distance of 567.79 feet to a 1 inch iron pipe (found);

thence S 00° 47' 12" W, a distance of 204.72 feet to a 1 inch iron pipe (found);

thence N 88° 59' 49" W, a distance of 1,202.69 feet to the POINT OF BEGINNING, passing at 1,177.69 feet a 5/8 inch iron pin (set). This parcel contains 101.591 acres, more or less, subject to all legal highways and easements of record.
