SURVEYOR'S DESCRIPTION TRACT ONE

Being a tract of land situate in the east half of the northeast quarter of Section 15, Town-6-South, Range-6-East, Pusheta Township, Auglaize County, Ohio, as evidenced by Official Record Volume 358, Pages 143 and 146 and more particularly described as follows:

Commencing for reference at the northeast corner of the east half of the northeast quarter of Section 15 and the centerline of Wapak-Freyburg Road and Pusheta Road; thence, N 89 degrees 09' 30" W along the north line of the east half of the northeast quarter of Section 15 and the centerline of Pusheta Road, for a distance of 1142.18 feet to a cotton gin spindle (set), said spindle being the **POINT OF BEGINNING** for the tract herein described;

thence, S 00 degrees 32' 30" W (passing through a 5/8" re-rod w/cap set on the south right-of-way line of Pusheta Road at a distance of 20.00 feet) for a total distance of 484.04 feet to a mag-nail (set) in concrete;

thence, S 80 degrees 12' 30" W (passing through a 1" iron pipe found at a distance of 186.26 feet) for a total distance of 188.17 feet to a point on the west line of the east half of the northeast quarter of Section 15;

thence, N 00 degrees 32' 30" E along the aforesaid west line (passing through a 5/8" re-rod w/cap set on the south right-of-way line of Pusheta Road at a distance of 498.76 feet) for a total distance of 518.76 feet to a railroad spike (found) at the northwest corner of the east half of the northeast quarter of Section 15 and the centerline of Pusheta Road;

thence, S 89 degrees 09' 30" E along the north line of the aforesaid east half, and the centerline of Pusheta Road for a distance of 185.12 feet to the **POINT OF BEGINNING**, containing therein **2.131 acres**, of which 0.085 acres is road right-of-way. Being a tract of land situate in the east half of the northeast quarter of Section 15, Town-6-South, Range-6-East, Pusheta Township, Auglaize County, Ohio, as evidenced by Official Record Volume 358, Pages 143 and 146 and more particularly described as follows:

Commencing for reference at the northeast corner of the east half of the northeast quarter of Section 15 and the centerline of Wapak-Freyburg Road and Pusheta Road; thence, N 89 degrees 09' 30" W along the north line of the east half of the northeast quarter of Section 15 and the centerline of Pusheta Road, for a distance of 945.13 feet to a cotton gin spindle (set), said spindle being the **POINT OF BEGINNING** for the tract herein described;

thence, S 00 degrees 32' 30" W (passing through a 5/8" re-rod w/cap set on the south right-of-way line of Pusheta Road at a distance of 20.00 feet) for a total distance of 447.08 feet to a 5/8" re-rod w/cap (set);

thence, S 80 degrees 12' 30" W for a distance of 200.30 feet to a mag-nail (set) in concrete;

thence, N 00 degrees 32' 30" E (passing through a 5/8" re-rod w/cap set on the south right-of-way line of Pusheta Road at a distance of 464.04 feet) for a total distance of 484.04 feet to a cotton gin spindle (set) on the north line of the east half of the northeast quarter of Section 15 and the centerline of Pusheta Road:

Commencing for reference at the northeast corner of the east half of the northeast quarter of Section 15 and the centerline of Wapak-Freyburg Road and Pusheta Road; thence, N 89 degrees 09' 30" W along the north line of the east half of the northeast quarter of Section 15 and the centerline of Pusheta Road, for a distance of 727.30 feet to a cotton gin spindle (set), said spindle being the **POINT OF BEGINNING** for the tract herein described:

thence, S 00 degrees 32' 30" W (passing through a 5/8" re-rod w/cap set on the south right-of-way line of Pusheta Road at a distance of 20.00 feet) for a total distance of 406.22 feet to an 8" diameter wood post (found);

thence, S 80 degrees 12' 30" W for a distance of 221.42 feet to a 5/8" re-rod w/cap (set);

thence, N 00 degrees 32' 30" E (passing through a 5/8" re-rod w/cap set on the south right-of-way line of Pusheta Road at a distance of 427.08 feet) for a total distance of 447.08 feet to a cotton gin spindle (set) on the north line of the east half of the northeast quarter of Section 15 and the centerline of Pusheta Road:
