

## PARCEL 1 LEGAL DESCRIPTION

Being Part of Parcel #I24-231-003-01 and #I24-231-003-03 as described in Volume 239, Page 330 and Volume 246, Page 394 of the Auglaize County Official Record of Deeds. Situated in the SE ¼ of Section 23, T-6-S, R-6-E, Pusheta Township, County of Auglaize, State of Ohio a tract of land bounded and described as follows:

Commencing at a monument box over an iron pin found at the southwest corner of said SE ¼ of Section 23; Thence along the west line of said SE ¼ of Section 23, also being the centerline of Shelby-Fryburg Road (TR 173), N 00°-53'-31" E (basis of bearing) a distance of 464.27 feet to a set mag nail;

Thence S 89°-06'-29" E a distance of 0.96 feet to a set mag nail marking the southwest corner of a 0.854 acre tract surveyed by Thomas W. Steinke, PS #6177 on May 28, 1974 recorded in Survey Book A, Page 71; Thence parallel with said west line of the SE ¼ of Section 23, N 00°-53'-31" E a distance of 448.03 feet to a set mag nail, passing a railroad spike found at 339.85 feet marking the southwest corner of a 1.179 acre tract surveyed by Thomas W. Steinke, PS #6177 on October 9, 1978 recorded in Survey Book D, Page 189, being the POINT OF BEGINNING for the tract of land herein described;

thence continuing parallel with said west line of the SE ¼ of Section 23, N 00°-53'-31" E a distance of 41.82 feet to a PK nail & shiner found marking the northwest corner of said 1.179 acre tract;

thence along the north line of said 1.179 acre tract, S 85°-56'-29" E a distance of 342.75 feet to a point in a pond, passing a set 5/8 inch iron pin w/ cap at 19.07 feet on the east right-of-way line of said Shelby-Fryburg Road (TR 173) and passing a set 5/8 inch iron pin w/ cap at 287.75 feet;

thence parallel with said west line of the SE ¼ of Section 23, S 00°-53'-31" W a distance of 150.00 feet to a set 5/8 inch iron pin w/ cap marking the southeast corner of said 1.179 acre tract;

thence N 85°-56'-29" W a distance of 50.00 feet to a set 5/8 inch iron pin w/ cap;

thence parallel with said west line of the SE ¼ of Section 23, S 00°-53'-31" W a distance of 155.00 feet to a set 5/8 inch iron pin w/ cap;

thence N 85°-56'-29" W a distance of 22.76 feet to a set 5/8 inch iron pin w/ cap;

thence parallel with said west line of the SE ¼ of Section 23, N 00°-53'-31" E a distance of 284.30 feet to a set 5/8 inch iron pin w/ cap;

thence S 89°-34'-23" W a distance of 269.65 feet, passing a set 5/8 inch iron pin w/ cap at 250.61 feet on the east right-of-way line of said Shelby-Fryburg Road (TR 173) to the POINT OF BEGINNING.

The above described parcel contains 0.525 acres of land, of which 0.018 acres of land is occupied by the right-of-way of Shelby-Fryburg Road (TR 173), subject to all legal highways and easements of record at the time of recording of this instrument.

## PARCEL 2 LEGAL DESCRIPTION

Being Part of Parcel #I24-231-003-00 as described in OR Vol. 436, Page 1447 and OR Vol. 436, Page 1449 of the Auglaize County Official Record of Deeds. Situated in the SE ¼ of Section 23, T-6-S, R-6-E, Pusheta Township, County of Auglaize, State of Ohio a tract of land bounded and described as follows:

Commencing at a monument box over an iron pin found at the southwest corner of said SE ¼ of Section 23; Thence along the west line of said SE ¼ of Section 23, also being the centerline of Shelby-Fryburg Road (TR 173), N 00°-53'-31" E (basis of bearing) a distance of 464.27 feet to a set mag nail;

Thence S 89°-06'-29" E a distance of 0.96 feet to a set mag nail marking the southwest corner of a 0.854 acre tract surveyed by Thomas W. Steinke, PS #6177 on May 28, 1974 recorded in Survey Book A, Page 71; Thence along the centerline of Pusheta Creek, S 66°-50'-29" E a distance of 177.93 feet to a point marking the southeast corner of said 0.854 acre tract, being the POINT OF BEGINNING for the tract of land herein described;

thence along the east line of said 0.854 acre tract parallel with said west line of the SE ¼ of Section 23, N 00°-53'-31" E a distance of 243.16 feet to a 5/8 inch iron pin found marking the northeast corner of said 0.854 acre tract, passing a set 5/8 inch iron pin w/ cap at 50.00 feet;

thence S 85°-56'-29" E a distance of 105.06 feet to a set 5/8 inch iron pin w/ cap;

thence parallel with said west line of the SE ¼ of Section 23, S 00°-53'-31" W a distance of 280.31 feet to a point on said centerline of Pusheta Creek, passing a set 5/8 inch iron pin w/ cap at 230.31 feet;

thence along said centerline of Pusheta Creek, N 66°-50'-29" W a distance of 113.35 feet to the POINT OF BEGINNING.
