



SURVEYOR'S DESCRIPTION

scale:

Being a part of Lot 185 of Grandview Estates Subdivision No. 4 to the City of Wapakoneta, Auglaize County, Ohio and more particularly described as follows:

Commencing for reference at a p-k nail (found) at the intersection of the north line of Grandview Estates Subdivision No 4 and the centerline of Defiance Street (State Route 198); thence, S 89 degrees 29' 32" W along the aforesaid north line of Grandview No. 4, for a distance of 209.96 feet to a 5/8" re-rod w/cap (set), at the northeast corner of Lot 185, said re-rod being the **POINT OF BEGINNING** for the parcel herein described;

thence, S 02 degrees 29' 40" E for a distance of 182.24 feet to a 5/8" re-rod w/cap (set) on the north right-of-way line of Magnolia Drive and the south line of Lot 185;

thence, N 89 degrees 38' 12" W along the aforesaid north right-of-way line and south lot line, for a distance of 50.00 feet to a 5/8" re-rod w/cap set at a point of curve;


thence, along a curve to the right (concave to north), having a central angle which measures 58 degrees 10' 05", a radius which measures 20.00 feet, a chord which bears N 60 degrees 33' 09" W and a chord which measures 19.44 feet, for a total arc length of 20.30 feet to a 5/8" re-rod w/cap (set);

thence, N 31 degrees 28' 07" W along the easterly right-of-way line of Gardenia Drive, for a distance of 60.30 feet to a 5/8" re-rod w/cap (set);

thence, N 00 degrees 43' 39" E along the west line of Lot 185, for a distance of 119.98 feet to a 5/8" re-rod w/cap (set) at the northeast corner of Lot 185;

thence, N 89 degrees 29' 32" E along the north line of Lot 185, for a distance of 88.96 feet to the **POINT OF BEGINNING**, containing therein 15,886 square feet and subject to all easements, right-of-way and plat restrictions of record at the time of the recording of this instrument. Basis of bearings is per the plat of Grandview Estates No. 4 depicting the centerline of Defiance Street (S.R. 198) as S 31 degrees 26' 00" E. Prepared by James M.
