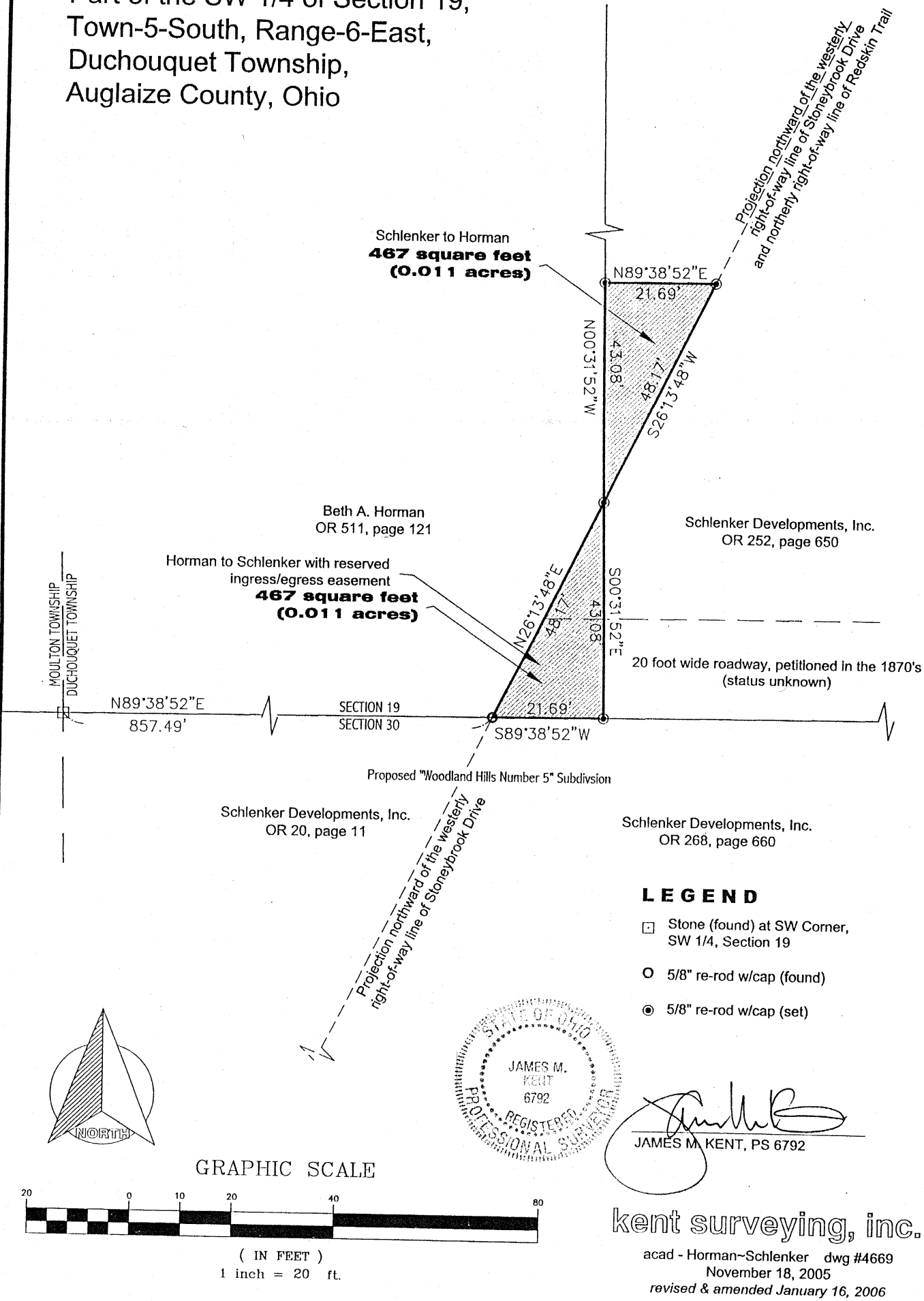
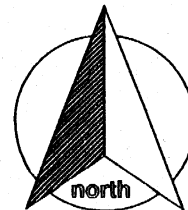


# Horman to Schlenker ~ Schlenker to Horman Survey

### SURVEYOR'S DESCRIPTION

Being a part of the southwest quarter of Section 19, Town-5-South, Range-6-East, Duchouquet Township, Auglaize County, Ohio as evidenced by Official Record Volume 511, Page 121, and more particularly described as follows:

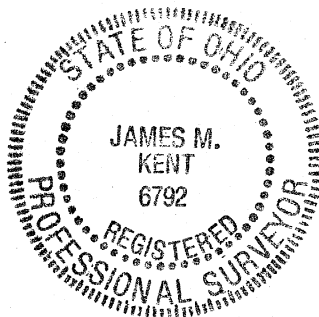
Commencing for reference at a stone (found) at the southwest corner of the southwest quarter of Section 19; thence, N 89 degrees 38' 52" E along the south line of the southwest quarter of Section 19, for a distance of 857.49 feet to a 5/8" re-rod w/cap (found) on the proposed northward projection of the westerly right-of-way line of Stoneybrook Drive, said re-rod being the **POINT OF BEGINNING**, for the parcel herein described;

thence, N 26 degrees 13' 48" E (along the aforesaid proposed northward projection of the westerly right-of-way line of Stoneybrook Drive) for a distance of 48.17 feet to a 5/8" re-rod w/cap (set);

thence, S 00 degrees 31' 52" E for a distance of 43.08 feet to a 5/8" re-rod w/cap (set) on the south line of the southwest quarter of Section 19;

thence, S 89 degrees 38' 52" W along the aforesaid south line, for a distance of 21.69 feet to the **POINT OF BEGINNING**, containing therein **467 square feet or 0.011 acres**. Reserving to the Grantor an easement for ingress and egress across the southerly twenty (20) feet of the subject property, to be in effect until such time as the subject tract is dedicated for public right-of-way. 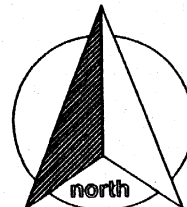

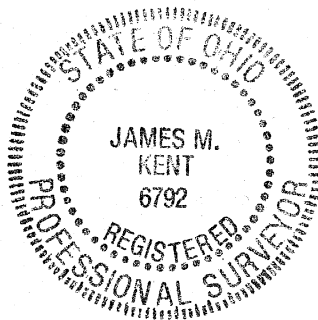
Being a part of the southwest quarter of Section 19, Town-5-South, Range-6-East, Duchouquet Township, Auglaize County, Ohio as evidenced by Official Record Volume 252, Page 650, and more particularly described as follows:

Commencing for reference at a stone (found) at the southwest corner of the southwest quarter of Section 19; thence, N 89 degrees 38' 52" E along the south line of the southwest quarter of Section 19, for a distance of 857.49 feet to a 5/8" re-rod w/cap (found) on the proposed northward projection of the westerly right-of-way line of Stoneybrook Drive; thence N 26 degrees 13' 48" E along the aforesaid proposed northward projection, for a distance of 48.17 feet to a 5/8" re-rod w/cap (set) on the common line of between that parcel evidenced by OR Volume 511, Page 121 and that tract evidenced by OR Volume 252, Page 650, said re-rod being the **POINT OF BEGINNING**, for the parcel herein described;

thence, N 00 degrees 31' 52" W for a distance of 43.08 feet to a 5/8" re-rod w/cap (set);


thence, N 89 degrees 38' 52" E for a distance of 21.69 feet to a 5/8" re-rod w/cap (set);

thence, S 26 degrees 13' 48" W for a distance of 48.17 feet to the **POINT OF BEGINNING**, containing therein **467 square feet or 0.011 acres**. Prepared by James M.
