



## SURVEYOR'S DESCRIPTION

scale:

Being a part of the southwest quarter of the northwest quarter of Section 21, Town-5-South, Range-4-East, Noble Township, Auglaize County, Ohio, as evidenced by Official Record Volume 512, Page 1754 and more particularly described as follows:

Commencing for reference at a monument box (found) at the southwest corner of the northwest quarter of Section 21 and the legal centerline of State Route 116; thence, N 01 degree 07' 32" E along the west line of the northwest quarter of Section 21 and the legal centerline of State Route 116, for a distance of 664.28 feet to the southwest corner of the north half of the southwest quarter of the northwest quarter of Section 21, and the **POINT OF BEGINNING** for the tract herein described;

thence, continuing along the aforesaid west line and centerline N 01 degree 07' 32" E, for a distance of 10.00 feet to a mag-nail (set);

thence, S 88 degrees 43' 30" E (passing through a 5/8" re-rod w/cap set on the east right-of-way line of State Route 116 at a distance of 30.00 feet) for a total distance of 241.00 feet to a 5/8" re-rod w/cap (set);

thence, S 01 degree 07' 32" W for a distance of 10.00 feet to a point on the south line of the north half of the southwest quarter of the northwest quarter of Section 21;

thence, N 88 degrees 43' 30" W along the aforesaid south line, for a distance of 241.00 to the **POINT OF BEGINNING**, containing therein **0.055** acres, of which 0.006 acres is road right-of-way. Subject to all easements and right-of-way of record at the time of the recording of this instrument. Prepared by James M. Being a part of the southwest quarter of the northwest quarter of Section 21, Town-5-South, Range-4-East, Noble Township, Auglaize County, Ohio, as evidenced by Official Record Volume 512, Page 1754 and Official Record Volume 527, Page 1135 and more particularly described as follows:

Commencing for reference at a monument box (found) at the southwest corner of the northwest quarter of Section 21 and the legal centerline of State Route 116; thence, N 01 degree 07' 32" E along the west line of the northwest quarter of Section 21 and the legal centerline of State Route 116, for a distance of 403.18 feet to a mag-nail (set), said nail being the **POINT OF BEGINNING** for the tract herein described;

thence, continuing along the aforesaid west line and centerline N 01 degree 07' 32" E, for a distance of 271.10 feet to a mag-nail (set);

thence, S 88 degrees 43' 30" E (passing through a 5/8" re-rod w/cap set on the east right-of-way line of State Route 116 at a distance of 30.00 feet) for a total distance of 241.00 feet to a 5/8" re-rod w/cap (set);

thence, S 01 degree 07' 32" W for a distance of 271.10 feet to a 5/8" re-rod w/cap (set);

thence, N 88 degrees 43' 30" W (passing through a 5/8" re-rod w/cap set on the east right-of-way line of State Route 116 at a distance of 211.00 feet) for a total distance of 241.00 feet to the **POINT OF BEGINNING**, containing therein **1.500 acres**, of which 0.186 acres is road right-of-way.
