



Tangeman Survey

**Legal Description for Deed
Tangeman Survey
Cloverleaf Farms Partnership, Grantor.**

Real Estate situated in German Township, Auglaize County, State of Ohio and bounded and described as follows:

Being a part of the north half of the northeast quarter of Section 4, Town 7 South, Range 4 East, commencing at an iron pin in a monument box at the northwest corner of the northeast quarter of said Section 4; thence North 89° 50' 27" East 50.00 feet along the North line of the northeast quarter of said Section 4 and centerline of Clover Four Road to a railroad spike for the true point of beginning;

thence continuing North 89° 50' 27" East 225.00 feet along the North line of the northeast quarter of said Section 4 and centerline of Clover Four Road to a railroad spike;

thence South 00° 38' 13" East 450.00 feet to an iron pin, passing through an iron pin for reference at the existing south right-of-way line of Clover Four Road at 30.00 feet;

thence South 89° 50' 27" West 225.00 feet to an iron pin;


thence North 00° 38' 13" West 450.00 feet, parallel with the West line of the northeast quarter of said Section 4, to the point of beginning, passing through an iron pin for reference at the existing south right-of-way line of Clover Four Road at 422.00 feet, containing 2.324 acres of land more or less of which 0.155 acre is existing right-of-way.

Said tract shall be subject to highways and to any other easement or restriction of record.

Basis of bearing on the north line of the northeast quarter of said Section 4 and centerline of Clover Four Road is from a previous survey completed in August, 1995.
