

DESCRIPTION JOB #15515 REMAINDER 4.341 ACRES

Being Tax Parcel F19-031-009-05 situated in the Southwest Quarter of Section 31, Township 4 South, Range 5 East, Logan Township, Auglaize County, Ohio, and being the remainder of a 23.95-acre tract granted to Peggy J. Fisher by Warranty Deed recorded in Deed Book 88, Page 603, of the Auglaize County, Ohio, deed records and being more particularly described as follows:

Commencing for reference at a 1-1/2" uncapped iron pipe found marking the southeast corner of the Southwest Quarter of said Section 31 -

Thence South 89°-56'-43" West (assumed bearing) on and along the south line of said Southwest Quarter for a distance of 558.98 feet to a 5/8-inch iron pin set marking the PRINCIPAL POINT OF BEGINNING for the parcel to be described by this instrument -

Thence continuing South 89°-56'-43" West on and along said south line for a distance of 378.08 feet to a 5/8-inch iron pin with "S&A, Lima OH" cap found -

Thence North 00°-08'-18" East for a distance of 693.12 feet to a PK nail found on the centerline of State Route 197, passing at 658.36 feet a 5/8-inch iron pin set -

Thence South 59°-31'-00" East on and along said centerline for a distance of 390.40 feet to a PK nail found -

Thence South 30°-29'-00" West for a distance of 253.16 feet to a 5/8-inch iron pin with "S&A, Lima, OH" cap found, passing at 30.00 feet a 5/8-inch iron pin with "S&A Lima, OH" cap found -

Thence South 59°-31'-00" East for a distance of 195.20 feet to a 5/8-inch iron pin with "S&A Lima, OH" cap found -

Thence South 00°-03'-17" East for a distance of 177.53 feet to the place of beginning.

Containing in all 4.341 acres of land, of which 0.263 acres are within the State Route 197 right of way, and being subject, however, to all legal easements and rights of way.

The foregoing description is based on field surveys completed from June, 1992, through May 31, 2006, under the supervision of Ohio Registered Professional Surveyor James D. Sheldon (#4569).
