## GILBERT SURVEY TRACT 1 1.294 ACRE TRACT

SITUATE IN THE SOUTHWEST QUARTER OF SECTION 10, TOWN 5S, RANGE 6E DUCHOUQUET TOWNSHIP, AUGLAIZE COUNTY OHIO, BEING PART OF THOSE LANDS OWNED BY CARL F. GILBERT AS RECORED IN OFFICIAL RECORD 380 PAGE 160 AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

Beginning for reference at a stone found in a monument box at the northwest corner of the southwest quarter of said Section 10 and being in the center of Hauss Road;

Thence, with the west line of the southwest quarter of said Section 10 and the centerline of Hauss Road, South 00°01'00" East, 363.93 feet to a Mag Nail set, said Mag Nail marking the **True Point of Beginning** of the tract herein described;

Thence, with the south line of an 87.15 acre tract of land owned by J. & C. Hager as recorded in Official Record 532 Page 2043, North 89°44'23" East, 313.23 feet to an iron pin set in the west line of The Western Ohio Rail Company as recorded in Deed Volume 73 Page 141, passing for reference at 25.00 feet an iron pin set in the east right of way line of Hauss Road;

Thence, with the west line of The Western Ohio Rail Company lands, South 23°38'18" West, 136.80 feet to an iron pin set;

Thence, with a new division line, South 49°22'15" West, 157.46 feet to an iron pin set;

Thence, with a new division line, South 87°27'51" West, 138.94 feet to a Mag Nail set in the west line of the southwest quarter of said Section 10 and the centerline of Hauss Road, passing for reference at 113.92 feet an iron pin set in the east right of way line of Hauss Road;

Thence, with the west line of the southwest quarter of said Section 10 and the centerline of Hauss Road, North 00°01'00" West, 232.57 feet to the **True Point of Beginning**, containing 1.294 acres more or less of which 0.133 acres lie within the right of way of Hauss Road and being subject to all legal rights of way, easements, restrictions and agreements of record.

Bearings listed above are assumed and shown for angular measurement only. The records referenced are all recorded in the Auglaize County Recorder's Office and the Auglaize County Tax Map Office. Pins noted as set are 5/8" x 30" rebar with orange plastic caps stamped "Lock-Two 7988".



## GILBERT SURVEY TRACT 2 1.272 ACRE TRACT

SITUATE IN THE SOUTHWEST QUARTER OF SECTION 10, TOWN 5S, RANGE 6E DUCHOUQUET TOWNSHIP, AUGLAIZE COUNTY OHIO, BEING PART OF THOSE LANDS OWNED BY CARL F. GILBERT AS RECORED IN OFFICIAL RECORD 380 PAGE 160 AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

Beginning for reference at a stone found in a monument box at the northwest corner of the southwest quarter of said Section 10 and being in the center of Hauss Road;

Thence, with the west line of the southwest quarter of said Section 10 and the centerline of Hauss Road, South 00°01'00" East, 596.50 feet to a Mag Nail set, said Mag Nail marking the **True Point of Beginning** of the tract herein described;

Thence, with a new division line, North 87°27'51" East, 138.94 feet to an iron pin set, passing for reference at 25.02 feet an iron pin set in the east right of way line of Hauss Road;

Thence, with a new division line, North 49°22'15" East, 157.46 feet to an iron pin set in the west line of The Western Ohio Rail Company as recorded in Deed Volume 73 Page 141

Thence, with the west line of The Western Ohio Rail Company lands, South 23°38'18" West, 643.87 feet to a Mag Nail set in the west line of the southwest quarter of said Section 10 and the centerline of Hauss Road, passing for reference at 581.56 feet an iron pin set in the east right of way line of Hauss Road;

Thence, with the west line of the southwest quarter of said Section 10 and the centerline of Hauss Road, North 00°01'00" West, 481.17 feet to the **True Point of Beginning** containing 1.272 acres more or less of which 0.260 acres lie within the right of way of Hauss Road and being subject to all legal rights of way, easements, restrictions and agreements of record.
