## FLEDDERJOHANN SURVEY 9.883 ACRES

SITUATE IN THE NORTHEAST QUARTER OF SECTION 25, TOWN 6S, RANGE 4E ST. MARYS TOWNSHIP, AUGLAIZE COUNTY OHIO, AND BEING PART OF THOSE LANDS OWNED BY MYRON AND BEVERLY FLEDDERJOHANN AS RECORDED IN DEED VOLUME 190 PAGE 952 AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

Beginning at a P.K. nail found, said P.K. nail marking the northwest corner of the northeast quarter of said Section 25, the centerline of State Route 219 and also marking the **Point of Beginning** of the tract herein described;

Thence, with the north line of the northeast quarter of said Section 25 and the centerline of State Route 219, South 89°05'48" East, 649.18 feet to a Mag Nail set;

Thence, with a new division line, South 01°20'22" West, 663.52 feet to an iron pin set, passing for reference at 30.00 feet an iron pin set in the south right of way line of State Route 219;

Thence, with a new division line, North 89°14'44" West, 646.84 feet to an iron pin set in the west line of the northeast quarter of said Section 25 and the east line of a 5.480 acre tract of land owned by J. & J. Hoge as recorded in Deed Volume 191 Page 843;

Thence, with the west line of the northeast quarter of said Section 25 and the east line of aforesaid 5.480 acre tract, North 01°08'09" East, 665.19 feet to the **Point of Beginning**, passing for reference at 635.19 feet an iron pin set in the south right of way line of State Route 219, containing 9.883 acres more or less of which 0.447 acres lie within the right of way of State Route 219 and being subject to all legal rights of way, easements, agreements and restrictions of record.

Bearings listed above are based upon the west line of the northeast quarter of Section 25 being North 01°08'09" East as per Survey STM 25-1 as filed in the Auglaize County Tax Map Office. The deed records referenced are all recorded in the Auglaize County Recorder's Office. Pins noted as set are 5/8" x 30" rebar with orange plastic caps stamped "Lock-Two 7988".
