KATTERHEINRICH SURVEY 1.033 ACRES

SITUATE IN THE NORTHEAST QUARTER OF SECTION 30 TOWN 6S RANGE 5E, WASHINGTON TOWNSHIP, PART OF OUTLOT 27 VILLAGE OF NEW KNOXVILLE, AUGLAIZE COUNTY OHIO, AND BEING ALL OF THOSE LANDS OWNED BY MYRON AND JOANNE KATTERHEINRICH AS RECORDED IN OFFICIAL RECORD 38, PAGE 753 AND BEING MORE PARTICULLARY DESCRIBED AS FOLLOWS:

Beginning for reference at an iron pin with "S & A Lima" found at the northwest corner of Outlot 27;

Thence, with the north line of Part Outlot 27, South 89°15'29" East, 329.88 feet to an iron pin set, said iron pin marking the **True Point of Beginning** of the tract herein described;

Thence, with the south line of Part Outlot 28 owned by W. Ray as recorded in Official Record 361, Page 926, L. & K. Kruse as recorded in Deed Volume 224, Page 883 and S. & M. Mackenbach as recorded in Official Record 525, Page 73, South 89°15'29" East, 165.12 feet to an iron pin set;

Thence, with the west line of Part Outlot 27 owned by D. & R. Niemeyer as recorded in Deed Volume 153, Page 84, South 00°45'05" West, 272.38 feet to a Mag Nail set in the centerline of Bremen Street, passing for reference at 242.38 feet an iron pin set in the north right of way line of Bremen Street;

Thence, with the centerline of Bremen Street, North 89°15'29" West, 165.12 feet to a Mag Nail set;

Thence, with the east line of Part Outlot 27 owned by D. Miller as recorded in Official Record 542, Page 970, North 00°45'05" East, 272.38 feet to the **True Point of Beginning**, containing 1.033 acres more or less of which 0.114 acres lie within the right of way of Bremen Street, passing for reference at 30.00 feet an iron pin set in the north right of way line of Bremen Street and being subject to all legal rights of way, easements, agreements and restrictions of record:
