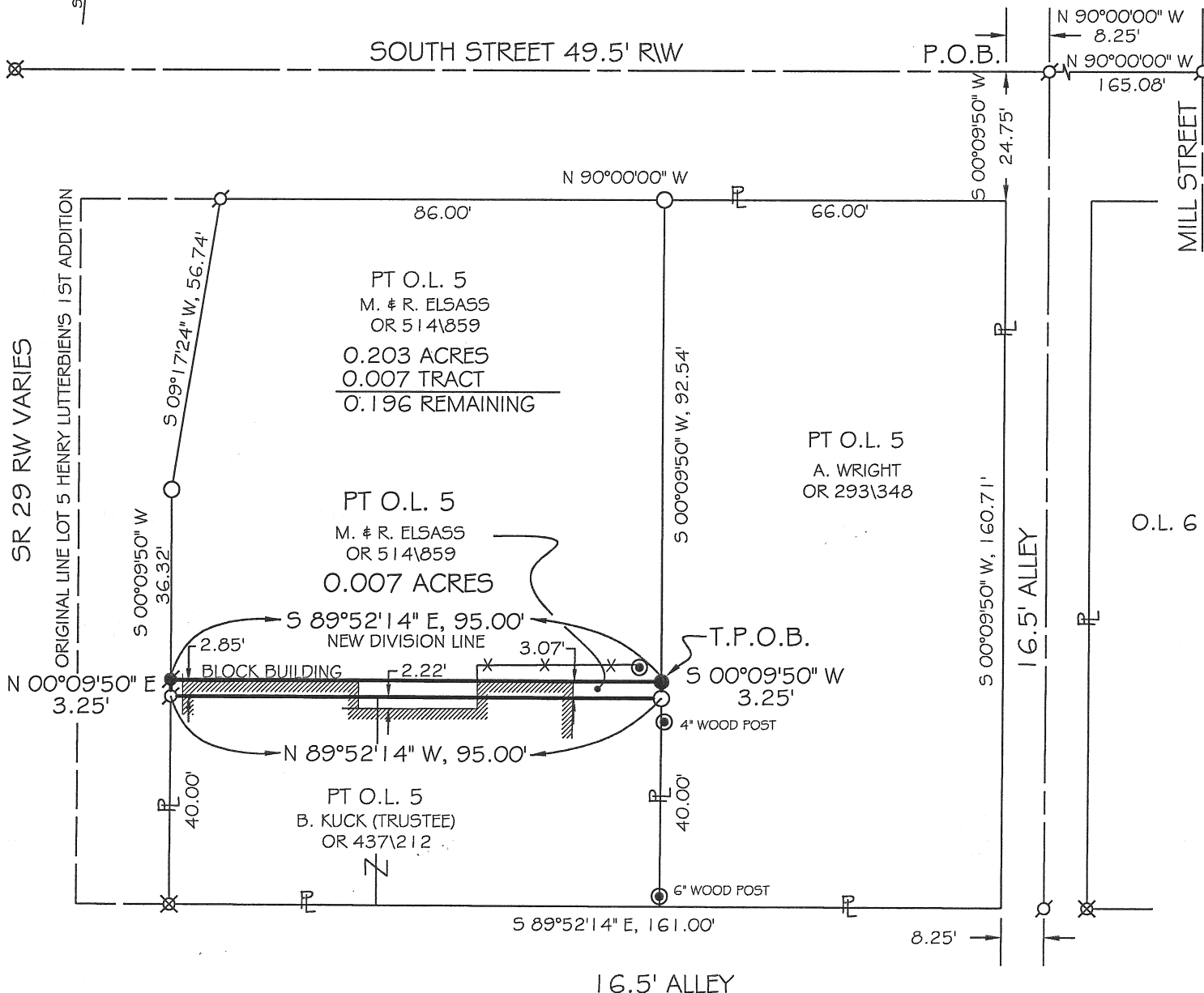
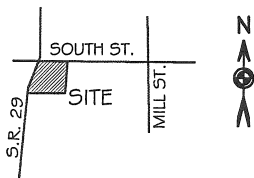

WASHINGTON TWP., AUGLAIZE COUNTY, OH

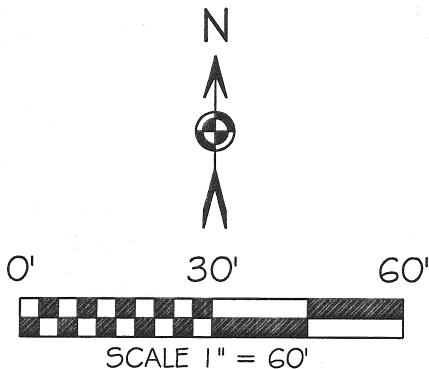
VICINITY MAP

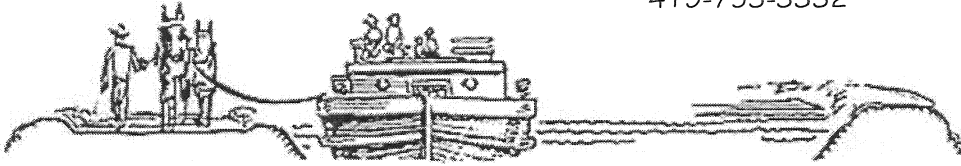

BEING A PART OF OUT LOT 5 OF HENRY LUTTERBIEN'S FIRST ADDITION TO THE VILLAGE OF NEW KNOXVILLE, AUGLAIZE COUNTY, OHIO, OWNED BY RICHARD AND MARY LOU ELSASS AS RECORDED IN OFFICIAL RECORD 514 PAGE 859 AND BEING MORE FULLY DESCRIBED AS FOLLOWS:

Beginning for reference at a Mag Nail in shiner found at the intersection of the centerline of South Street and the centerline of an alley between Out Lot 5 and Out Lot 6 of Henry Lutterbien's First Additon;

Thence, with the centerline of South Street, North 90°00'00" West, 8.25 feet;

Thence, South 00°09'00" West, 24.75 feet to the northeast corner of Out Lot 5 owned by A. Wright as recorded in Official Record 293, Page 348 and the south right of way line of South Street;

Thence, with the north line of Out Lot 5 and the south right of way line of South Street, North 90°00'00" West, 66.00 feet to an iron pin found at the northeast corner of a 0.203 acre tract of land and being Part of Out Lot 5, owned by Richard and Mary Elsass as recorded in Official Record 514, Page 859;

Thence, with the east line of said 0.203 acre tract and the west line of said Wright tract, South 00°09'50" West, 92.54 feet to an iron pin set, said iron pin marking the **True Point of Beginning** of the tract here in described;

Thence, continuing with the east line of said 0.203 acre tract, South 00°09'50" West, 3.25 feet to a iron pin found at the northeast corner of Part Out Lot 5 owned by B. Kuck Trustee as recorded in Official Record 437, Page 212;

Thence, with the north line of said Part Out Lot 5 owned by B. Kuck, North 89°52'14" West , 95.00 feet to a Mag Nail found;

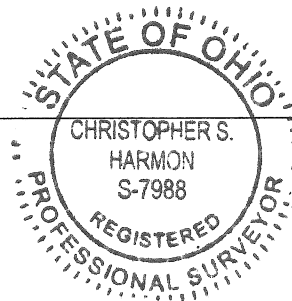
Thence, with the west line of said 0.203 acre tract, North 00°09'50" East, 3.25 feet to a Mag Nail set;

Thence, with a new division line, South 89°52'14" East , 95.00 feet to the **True Point of Beginning**, containing 0.007 acres more or less and being subject to all legal easements, rights of way, agreements and restrictions of record.

Bearings listed above based upon the centerline South Street being North 90°00'00" West as per Survey Book P, Page 127. The survey records referenced are all recorded in the Auglaize County Recorder's records and the Auglaize County Tax Map Office. Pins noted as set are 5/8" x 30" rebar with orange plastic caps stamped "Lock-Two 7988".
