## **DAMMEYER SURVEY** 5.164 AC.

SITUATE IN THE NORTHEAST AND SOUTHEAST QUARTER OF SECTION 21 TOWN 6S RANGE 4E. ST. MARYS TOWNSHIP, AUGLAIZE COUNTY OHIO, AND BEING PART OF THOSE LANDS OWNED BY KARL AND DENISE DAMMEYER AS RECORDED IN OFFICIAL RECORD 429 PAGE 90 AND BEING MORE PARTICULLARY DESCRIBED AS FOLLOWS:

Beginning at and iron pin set at the southwest corner of the northeast quarter of said Section 21, said iron pin also marking the True Point of Beginning of the tract herein described;

Thence, with the west line of said northeast quarter of Section 21, North 00°30'28" East, 266.05 feet to an iron pin set;

Thence, with a new division line the following 5 courses;

- 1. Thence, North 89°48'21" East, 430.51 feet to an iron pin set;
- 2. Thence, South 00°14'03" West, 270.38 feet to an Mag Nail set in the centerline of Dowty Road, passing for reference at 255.38 feet an iron pin set in the north right of way line of Dowty Road;
- 3. Thence with the center line of Dowty Road and the south line of the northeast quarter of said Section 21, North 89°37'22" West, 93.25 feet to a Mag Nail set;
- 4. Thence, South 01°24'15" West, 327.10 feet to and iron pin set, passing for reference at 15.00 feet and iron pin set in the south right of way line of Dowty Road;
- 5. Thence, North 89°02'39" West, 333.26 feet to and iron pin set in the west line of the southeast quarter of said Section 21;

Thence, with the west line of the southeast quarter of said Section 21, North 00°28'58" East, 323.71 feet to the True Point of Beginning, containing 5.164 acres more or less of which 0.265 acres lie in the right of way of Dowty Road and being subject to all legal rights of way, easements, agreements and restrictions of record;

Bearings listed above are based upon the centerline of Tri Township Road and the west line of the northwest quarter of Section 21 and being North 00°30'00" East as per Survey Book "O" Page 17 as filed in the Auglaize County Tax Map Office. The deed records referenced are all recorded in the Auglaize County Recorder's Office.
