

## DAMMEYER SURVEY 12.363 AC.

SITUATE IN THE NORTHWEST QUARTER OF SECTION 21 TOWN 6S RANGE 4E, ST. MARYS TOWNSHIP, AUGLAIZE COUNTY OHIO, AND BEING PART OF THOSE LANDS OWNED BY KARL AND DENISE DAMMEYER AS RECORDED IN OFFICIAL RECORD 404 PAGE 327 AND BEING MORE PARTICULLARY DESCRIBED AS FOLLOWS:

Beginning for reference at an iron pin found in a monument box at the southwest corner of the northwest quarter of said Section 21;

Thence, with the south line of a 1.480 acre tract of land owned by G. & M. Vanderhorst as recorded in Official Record 465 Page 1909, North 89°28'37" West, 308.71 feet to an iron pin set, said iron pin also marking the **True Point of Beginning** of the tract herein described;

Thence, with the east line of said 1.480 acre tract, a 1.479 acre tract of land owned by C. & S.Dine as recorded in Official Record 507, Page 2525, a 1.479 acre tract owned by D. & M. Miller as recorded in Official Record 105, Page 691, and a 1.479 acre tract owned by J. & P. Hammer as recorded in Official Record 137, Page 382, North 00°30'00" East, 835.44 feet to an iron pin set, witnessing at South 74°50'26" East, 2.49 feet an iron pin with Geeslin cap found;

Thence, with the south line of a 6.970 tract of land owned by M. & A. Imwalle, South 89°37'00" East, 643.99 feet, to an iron pin with Geeslin cap found;

Thence, with an new division line, South 00°30'00" West, 837.01 feet, to an iron pin set in the south line of the northwest quarter of said Section 21 and the north line of a 28.346 acre tract of land owned by R. & T. Bertke as recorded in Official Record 224, Page 173;

Thence, with the south line on the northwest quarter of said Section 21 and the north line of the said 28.346 acre tract and a 8.474 acre tract owned by R. & T. Bertke as recorded in Official Record 458, Page 1567, North 89°28'37" West, 643.99 feet to the **True Point of Beginning**, containing 12.363 acres more or less and being subject to all legal rights of way, easements, agreements and restrictions of record;

Bearings listed above are based upon the centerline of Tri Township Road and the west line of the northwest quarter of Section 21 and being North 00°30'00" East as per Survey Book "O" Page 17 as filed in the Auglaize County Tax Map Office. The deed records referenced are all recorded in the Auglaize County Recorder's Office.
