Commencing at an iron spike at the centerline intersection of Herman Street and Erie Street in the Village of New Bremen; thence North 00° 01' 00" East 294.35 feet along the centerline of Herman Street to a mag nail for the true point of beginning;

thence continuing North 00° 01' 00" East 81.00 feet along the centerline of Herman Street to an iron spike;

thence South 89° 44' 44" East 174.85 feet to an iron pin, passing through an iron reference pin at 25.00 feet;

thence South 00° 01' 00" West 81.00 feet to an iron pin;

Commencing at an iron spike at the centerline intersection of Herman Street and Erie Street in the Village of New Bremen; thence North 00° 01' 00" East 209.72 feet along the centerline of Herman Street to a P.K. nail for the true point of beginning;

thence continuing North 00° 01' 00" East 84.63 feet along the centerline of Herman Street to a mag nail;

thence South 89° 44' 44" East 174.85 feet to an iron pin, passing through an iron reference pin at 25.00 feet;
