## SURVEYOR'S DESCRIPTION

Being a part of the southwest quarter of Section 21, Town-5-South, Range-6-East, Duchouquet Township, Auglaize County, Ohio as evidenced by Official Record Volume 544, Page 1703 and more particularly described as follows:

Commencing for reference at a monument box (found) at the northeast corner of the east one-half of the southwest quarter of Section 21; thence, along the north line of said east one-half of the southwest quarter and the legal centerline of Infirmary Road, N 89° 28′ 36″ W for a distance of 615.00 feet to a mag-nail (set), said nail being the **POINT OF BEGINNING** for the tract herein described;

thence, S 01° 29′ 03″ W (passing through a 5/8″ re-rod w/cap set on the south right-of-way line of Infirmary Road at a distance of 25.00 feet) for a total distance of 300.00 feet to a 5/8″ re-rod w/cap (set);

thence, N 89° 28′ 36″ W for a distance of 85.00 feet to a 5/8″ re-rod w/cap (set);

thence, N 01° 29′ 03″ E (passing through a 5/8″ re-rod w/cap set on the south right-of-way line at a distance of 275.00 feet) for a total distance of 300.00 feet to a mag-nail (set) on the north line of the east one-half of the southwest quarter of Section 21 and the legal centerline of Infirmary Road;

thence, S 89° 28′ 36″ E along the aforesaid north line and legal centerline for a distance of 85.00 feet to the **POINT OF BEGINNING**, containing therein **0.585 acres**, of which 0.049 acres is road right-of-way. Subject to all easements and right-of-way of record at the time of the recording of this instrument. Prepared by James M.
