


HURLEY DESCRIPTION 1.604 ACRE

The following described tract of land is part of the North half of the Northwest Quarter of Section 3, Town 6 South, Range 6 East, Pusheta Township, Auglaize County, Ohio and is more particularly described as follows:

Commencing at an iron pin found at the Northeast corner of the Northwest Quarter of Section 3, Pusheta Township;

Thence S.01°21'30"E. a distance of 636.10 feet to a Monument Box in the centerline of County Road 33-A (Wapak-Fisher Road);

Thence N.58°40'00"W. along the centerline of County Road 33-A, a distance of 542.59 feet to a R.R. Spike found, which is the PLACE OF BEGINNING for the tract of land herein described;

Thence S.00°08'30"E. a distance of 175.16 feet to an iron pipe found;

Thence N.85°23'32"W. a distance of 489.55 feet to an iron pipe found;

Thence N.36°42'12"W. a distance of 13.09 feet to an iron pipe found;

Thence N.16°15'42"E. a distance of 35.77 feet to an iron pin set;

Thence S.86°37'03"E. a distance of 47.43 feet to an iron pin set;

Thence N.64°45'39"E. a distance of 338.95 feet to an iron pin set for reference in the Southerly right-of-way line of County Road 33-A;

Thence N.31°20'00"E. a distance of 25.00 feet to a Mag Nail set in the centerline of County Road 33-A;

Thence S.58°40'00"E. along the centerline of County Road 33-A, a distance of 138.62 feet to the R.R. Spike, which was the true PLACE OF BEGINNING.

Commencing at an iron pin found at the Northeast corner of the Northwest Quarter of Section 3, Pusheta Township;

Thence S.01°21'30"E. a distance of 636.10 feet to a Monument Box in the centerline of County Road 33-A (Wapak-Fisher Road);

Thence N.58°40'00"W. along the centerline of County Road 33-A, a distance of 681.21 feet to a Mag Nail set, which is the PLACE OF BEGINNING for the tract of land herein described;

Thence S.31°20'00"W. a distance of 25.00 feet to an iron pin set in the Southerly right-of-way line of County Road 33-A;

Thence S.64°45'39"W. a distance of 338.95 feet to an iron pin set;

Thence N.86°37'03"W. a distance of 47.43 feet to an iron pin set;
