## FLEDDERJOHANN SURVEY 0.217 ACRES

SITUATE IN THE NORTHEAST QUARTER OF SECTION 25, TOWN 6S, RANGE 4E ST. MARYS TOWNSHIP, AUGLAIZE COUNTY OHIO, AND BEING PART OF THOSE LANDS OWNED BY WAYNE FLEDDERJOHANN AND KIM FLEDDERJOHANN AS RECORDED IN OFFICIAL RECORD 548 PAGE 1414 AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

Beginning at a P.K. nail found, said P.K. nail marking the northwest corner of the northeast quarter of said Section 25, the centerline of State Route 219;

Thence, with the west line of the northeast quarter of said Section 25 and the east line of a 5.840 acre tract of land owned by J. & J. Hoge as recorded in Deed Volume 191 Page 843, South 01°08'09" West, 665.19 feet to an iron pin with "Lock Two" cap found, said iron pin marking the **True Point of Beginning** of the tract herein described;

Thence, with the south line of a 9.883 acre tract of land owned by M. & B. Fledderjohann, South 89°14'44" East, 646.83 feet to an iron pin with "Lock Two" cap found;

Thence, with a new division line, South 01°20'22" West, 14.61 feet to an iron pin set;

Thence, with a new division line, North 89°14"45" West, 646.78 feet to an iron pin set in the west line of the northeast quarter of said Section 25 and the east line of the aforesaid 5.840 acre Hoge tract;

Thence, with a the west line of the northeast quarter of said Section 25 and east line of the aforesaid 5.480 acre tract, North 01°08'09" East, 14.61 feet to the **True Point of Beginning**, containing 0.217 acres more or less and being subject to all legal rights of way, easements, agreements and restrictions of record.

Bearings listed above are based upon the west line of the northeast quarter of Section 25 being North 01°08'09" East as per Survey STM 25-1 as filed in the Auglaize County Tax Map Office. The deed records referenced are all recorded in the Auglaize County Recorder's Office. Pins noted as set are 5/8" x 30" rebar with orange plastic caps stamped "Lock-Two 7988".
