

BOB SCHAUB DESCRIPTION 74.879 ACRE

The following described tract of land is part of the Southeast Quarter of Section 7, Town 6 South, Range 6 East, Pusheta Township, Auglaize County, Ohio and is more particularly described as follows:

The PLACE OF BEGINNING is at a Monument Box found at the Northeast corner of the Southeast Quarter of Section 7, Pusheta Township and in the intersection of the centerlines of County Road 133A (Hardin Pike) and Township Road 126 (Owl Creek Road);

Thence S.01°05'03"W. along the East line of the Southeast Quarter of Section 7 and the centerline of County Road 133-A (Hardin Pike), a distance of 1,867.26 feet to a

Mag Nail found;

Thence N.88°54'57"W. a distance of 400.00 feet to an iron pin found, passing thru an iron pin found at 25.00 feet in the East right-of-way line of County Road 133A;

Thence S.01°05'03"W., parallel to the centerline of County Road 133A and the East line of the Northeast Quarter of Section 7, a distance of 308.90 feet to an iron pin found;

Thence S.88°54'57"E. a distance of 400.00 feet to a P.K. nail found, passing thru an iron pin found at 375.00 feet in the West right-of-way line of County Road 133A;

Thence S.01°05'03"W. along the East line of the Southeast Quarter of Section 7 and the centerline of County Road 133A, a distance of 482.37 feet to a Monument Box found at the Southeast corner of the Southeast Quarter of Section 7, Pusheta Township;

Thence N.88°46'34"W. a distance of 1,329.08 feet to an iron pin set, passing thru an iron pin set for reference at 25.00 feet in the West right-of-way line of County Road 133A;

Thence N.01°02'13"E. along the West line of the East Half of the Southeast Quarter of Section 7, a distance of 2,359.43 feet to an iron pin found;

Thence S.89°09'03"E., parallel to the centerline of Township Road 126 and the North line of the Southeast Quarter of said Section 7, a distance of 500.00 feet to an iron pin found;

Thence N.01°02'13"E. a distance of 290.40 feet to a P.K. nail found;

Thence S.89°09'03"E. along the North line of the Southeast Quarter of Section 7, a distance of 831.26 feet to the Monument Box which was the true PLACE OF BEGINNING.

Containing in all 74.879 Acres of which 1.469 Acre is subject to easement for highway purposes. The above-described tract of land is subject to all legal easements, restrictions and reservations, if any, of record or in use on said premises. Previous deed reference: Volume 262, page 606. This plat is recorded in Survey Book "P", page 625, in the Auglaize County Engineer's Office. Basis of bearing is the North line of the Southeast Quarter of Section 7, and the centerline of Township Road 126 as S.89°09'03"E. (Auglaize County G.P.S. data). This description is based on an actual field survey, performed by me, John W. Jauert in May 2007.
