## SURVEYOR'S DESCRIPTION

scale:

Being a part of the southwest quarter of the northeast quarter of Section 35, Town-5-South, Range-4-East, Noble Township, Auglaize County, Ohio as evidenced by Deed Volume 218, Page 682 and more particularly described as follows:

Commencing for reference at a monument box (found) at the southwest corner of the northeast quarter of Section 35, and the legal centerline of Shipman Road; thence, with an assumed bearing of N 90 degrees 00' 00" E, along the south line of the northeast quarter of Section 35 and the legal centerline of Shipman Road, for a distance of 677.87 feet to a mag nail (set); said nail being the **POINT OF BEGINNING** for the tract herein described;


thence, N 00 degrees 10' 10" W for (passing through a 5/8" re-rod w/cap set on the north right-of-way line of Shipman Road at a distance of 15.00 feet) for a total distance of 270.07 feet to a 5/8" re-rod w/cap (set);

thence, N 90 degrees 00' 00" E for a distance of 152.00 feet to a 5/8" re-rod w/cap (found);

thence, S 00 degrees 10' 10" E (passing through 5/8" re-rod w/cap found on the north right-of-way line of Shipman at a distance of 255.07) for a total distance of 270.07 feet to a cotton gin spindle (found) on the south line of the northeast quarter of Section 35 and the legal centerline of Shipman Road;

thence, S 90 degrees 00' 00" W along the aforesaid south line and legal centerline for a distance of 152.00 feet to the **POINT OF BEGINNING**, containing therein **0.942 acres**, of which 0.052 acres is road right-of-way. Subject to all easements and right-of-ways of record at the time of the recording of this instrument. The above described tract is an "add-on" tract, and is not to be used for a separate residential dwelling. Basis of bearings is assumed. Prepared by James M.
