## SURVEYOR'S DESCRIPTION

Being a part of the southeast quarter of Section 29, Town-6-South, Range-5-East, Washington, Township, Auglaize County, Ohio as evidenced by Official Record Volume 65, Page 232 and more particularly described as follows:

Commencing for reference at a monument box (found) at the southeast corner of the southeast quarter of Section 29 and the centerline of Southland Road; thence, N 89° 33' 15" W along the south line of the southeast quarter of Section 29 and the centerline of Southland Road for a distance of 1022.04 feet to a mag nail (set), said mag nail being the **POINT OF BEGINNING** for the tract herein described;

thence, continuing along the aforesaid south line of the southeast quarter and the centerline of Southland Road N 89° 33' 15" W for a distance of 354.66 feet to a mag nail (set);

thence, N 01° 19′ 01″ E (passing through a 5/8″ re-rod w/cap set on the north right-of-way line of Southland Road and a 5/8″ re-rod w/cap set on the south right-of-way line of Botkins-Angle Road at a distance of 20.00 feet and 1200.05 feet respectively) for a total distance of 1238.25 feet to a mag-nail (set);

thence, S 50° 26' 43" E along the centerline of Botkins-Angle Road for a distance of 454.07 feet to a mag nail (set);

thence, S 01° 26′ 20″ W (passing through a 5/8″ re-rod w/cap set on the south right-of-way line of Botkins-Angle Road and a 5/8″ re-rod w/cap set on the north right-of-way line of Southland Road at a distance of 38.20 feet and 931.83 feet respectively) for a total distance of 951.83 feet to the **POINT OF BEGINNING**, containing therein **8.943 acres**, of which 0.313 acres is road right-of-way. Commencing for reference at a monument box (found) at the southwest corner of the southeast quarter of Section 29 and the centerline of Southland Road; thence, S 89° 33′ 15″ E along the south line of the southeast quarter of Section 29 and the centerline of Southland Road for a distance of 1622.57 feet to a mag nail (set); thence, N 01° 26′ 20″ E for a distance of 424.39 feet to a 5/8″ re-rod w/cap (set), said re-rod being the **POINT OF BEGINNING** for the tract herein described;

thence, continuing N 01° 26′ 20″ E (passing through a 5/8″ re-rod w/cap set on the south right-of-way line of Botkins Angle Road at a distance of 489.31 feet) for a total distance of 527.44 feet to a mag-nail (set) on the centerline of Botkins Angle Road;

thence, S 50° 26' 43" E along the centerline of Botkins Angle Road for a distance of 326.65 feet to a 5/8" re-rod (found);

thence, S 01° 26' 20" W (passing through a 5/8" re-rod w/cap set on the south right-of-way line of Botkins Angle Road at a distance of 38.13 feet) for a total distance of 321.25 feet to a 5/8" re-rod w/cap (set);
