

FRAZE-TRIMBACH SURVEY PART OF LOT NO. 2

The following described tract of land is part of Lot No. 2 in the Southmoor Shores Subdivision, located in the Southwest Quarter of Section 17, Town 6 South, Range 4 East, St. Marys Township, Auglaize County, Ohio and is more particularly described as follows:

The PLACE OF BEGINNING is at an iron pin found at the Southwest corner of Lot No. 2 in the Southmoor Shores Subdivision;

Thence N.01°42'24"E. along the West line of Lot No. 2, a distance of 142.29 feet to a point at the Northwest corner of said Lot No. 2;

Thence N.78°51'55"E. along the North line of said Lot No. 2, a distance of 2.97

feet to a point;
Thence S.01°18'28"W. a distance of 142.93 feet to an iron pin set, passing thru an iron pin set for reference at 9.33 feet;

Thence N.88°34'48"W. along the South line of Lot No. 2, a distance of 3.89 feet to the iron pin found, which was the true PLACE OF BEGINNING.

Containing in all 0.011 Acre or 484.0 Sq. Ft. The above described tract of land is subject to all legal easements, restrictions and reservations, if any, of record or in use on said premises. Previous deed reference: Volume OR 85, page 497. Basis of bearing is holding the West line of the Southwest Quarter of Section 17, and the original East line of Lot No. 2, as N.01°42'24"E. TRIMBACH SURVEY PART OF LOT 3 & PART OF LOT NO. 2

The following described tract of land is part of Lot No. 2 and part of Lot No. 3 in the Southmoor Shores Subdivision, located in the Southwest Quarter of Section 17, Town 6 South, Range 4 East, St. Marys Township, Auglaize County, Ohio and is more particularly described as follows:

Commencing at an iron pin set at the Southeast corner of Lot No. 2 in the Southmoor Shores Subdivision;

Thence S.88°34'48"E. along the South line of Lot No. 2, a distance of 5.06 feet to an iron pin set, which is the PLACE OF BEGINNING for the tract of land herein described;

Thence N.00°24'46"E., a distance of 118.85 feet to an iron pin set;

Thence N.49°19'53"W. a distance of 3.00 feet to an iron pin set;

Thence N.49°44'33"W. a distance of 47.08 feet to a point, passing thru an iron pin found at 30.07 feet;

Thence N.78°51'55"E. along the North line of Lot No. 2, a distance of 12.43 feet to a point;

Thence N.28°34'22"E. along the North line of Lot No. 3, a distance of 20.44 feet to a point;

Thence S.49°44'33"E. along the Easterly line of Lot No. 3, a distance of 160.06 feet to an iron pin found, passing thru an iron pin found at 10.00 feet;

Thence along a curve to the left, the chord of which bears S.20°50'43"W. a distance of 56.36 feet, having a radius of 85.00 feet to an iron pin found;

Thence S.01°36'23"W. a distance of 6.83 feet to an iron pin found;

Thence along a curve to the right, the chord of which bears S.46°30'48"W. a distance of 17.65 feet, having a radius of 12.50 feet to an iron pin found;


