

STILES / HABEGGER DESCRIPTION 1.100 ACRE

The following described tract of land is part of the Northwest Quarter of Section 14, Town 5 South, Range 7 East, Union Township, Auglaize County, Ohio and is more particularly described as follows:

Commencing at a Monument Box found at the Northeast corner of the Northwest Quarter of Section 14, Union Township and in the centerline of County Road 180 (Fairmount Road);

Thence S.89°30'00"W. along the North line of the Northwest Quarter of Section 14 and the centerline of County Road 180, a distance of 1,606.90 feet to a Mag Nail set which is the PLACE OF BEGINNING for the tract of land herein described;

Thence S.00°06'35"W. a distance of 1,320.50 feet to an iron pin set; Thence S.89°22'39"W. a distance of 29.26 feet to an iron pin found;


Thence N.00°30'00"W. a distance of 1,320.49 feet to a P.K. Nail found, passing thru an iron pin found at 1,260.49 feet in the South right-of-way line of County Road 180.

Thence N.89°30'00"E. along the centerline of County Road 180 and the North line of the Northwest Quarter of said Section 14, a distance of 43.31 feet to the Mag Nail which was the true PLACE OF BEGINNING.

Containing in all 1.100 Acres of which 0.059 Acre has been dedicated for highway purposes. The above-described tract of land is subject to all legal easements, restrictions and reservations, if any, of record or in use on said premises. Previous deed reference: Volume OR 538, page 1,424. This plat is recorded in Survey Book "P", page 698, in the Auglaize County Engineer's Office. Basis of bearing is the North line of the Northwest Quarter of Section 14, and the centerline of County Road 180 as S.89°30'00"W. (from a previous survey). STILES / HABEGGER DESCRIPTION 54.590 ACRE

The following described tract of land is part of the Northwest Quarter of Section 14, Town 5 South, Range 7 East, Union Township, Auglaize County, Ohio and is more particularly described as follows:

Commencing at a Monument Box found at the Northeast corner of the Northwest Quarter of Section 14, Union Township and in the centerline of County Road 180 (Fairmount Road);

Thence S.89°30'00"W. along the North line of the Northwest Quarter of Section 14 and the centerline of County Road 180, a distance of 561.51 feet to a P.K. Nail found, which is the PLACE OF BEGINNING for the tract of land herein described;

Thence S.00°01'40"E. a distance of 251.89 feet to an iron pin found, passing thru an iron pin found at 60.00 feet in the South right-of-way line of County Road 180;

Thence N.89°30'00"E., parallel to the centerline of County Road 180 and the North line of the Northwest Quarter of Section 14, a distance of 227.00 feet to an iron pin found;

Thence S.00°01'40"E. a distance of 2,383.59 feet to an iron pin found;

Thence S.89°15'21"W. along the South line of the Northwest Quarter of Section 14, a distance of 1,009.91 feet to an iron pin found;

Thence N.00°06'35"E. a distance of 1,319.92 feet to an iron pin found;

Thence N.89°22'39"E. a distance of 166.76 feet to an iron pin set;

Thence N.00°06'35"E. a distance of 1,319.57 feet to a Mag Nail set, passing thru an iron pin set at 1,259.57 feet in the South right-of-way line of County Road 180;


Thence N.89°30'00"E. along the North line of the Northwest Quarter of Section 14, a distance of 609.77 feet to the Mag Nail, which was the true PLACE OF BEGINNING.
