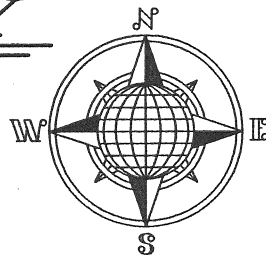


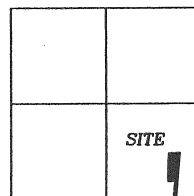

## LOCATION PLAN

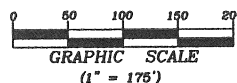

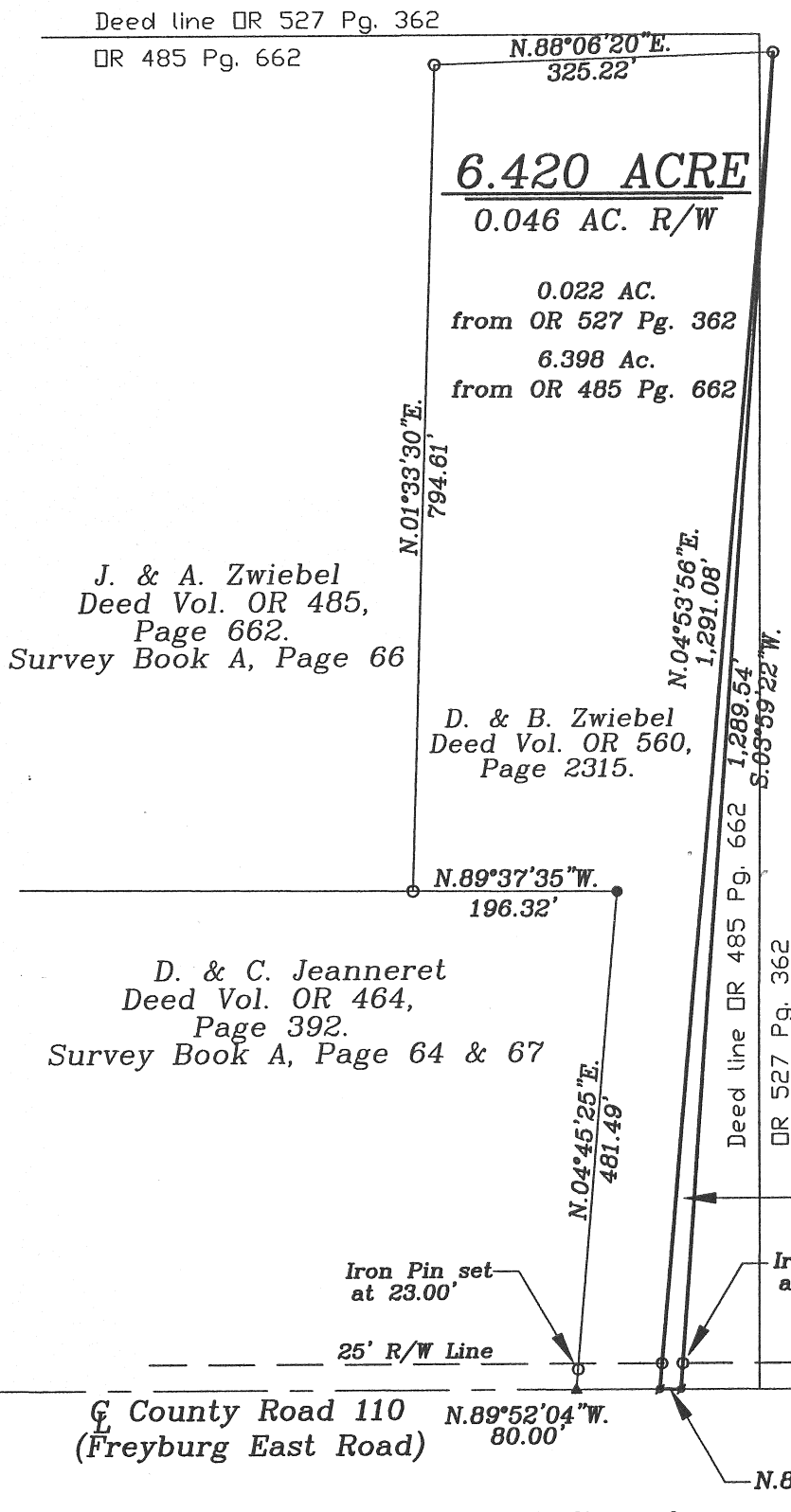

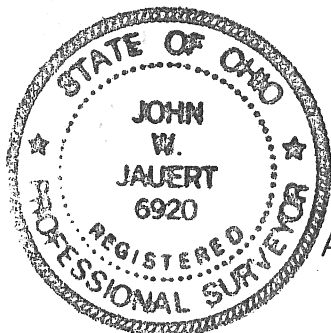

**DANNY ZWIEBEL ADD-ON SURVEY  
0.303 ACRE TRACT**

The following described tract of land is part of the Southeast Quarter of Section 14, Town 6 South, Range 6 East, Pusheta Township, Auglaize County, Ohio and is more particularly described as follows:

Commencing at a monument box located at the Southeast corner of the Southeast Quarter of Section 14, Pusheta Township and in the intersection of the centerlines of County Road 110 (Freyburg East Road) and Township Road 181 (Winemiller Road);

Thence N.89°52'04"W. along the centerline of County Road 110 and the South line of the Southeast Quarter of Section 14, Pusheta Township, a distance of 683.43 feet to a Mag Nail set which is the PLACE OF BEGINNING for the tract of land herein described;


Thence continuing N.89°52'04"W. along the above described line, a distance of 20.54 feet to a Mag Nail found;

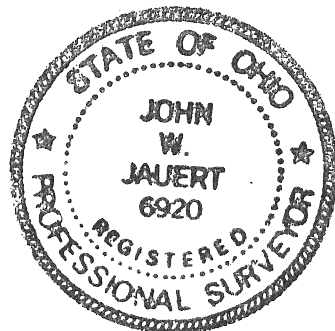
Thence N.04°53'56"E. a distance of 1,291.08 feet to an iron pin found, passing thru an iron pin set for reference at 25.09 feet in the North right-of-way line of County Road 110;

Thence S.03°59'22"W. a distance of 1,289.54 feet to a Mag Nail set, passing thru an iron pin set for reference at 1,264.48 feet in the North right-of-way line of County Road 110, said Mag Nail was the true PLACE OF BEGINNING.

Containing in all 0.303 Acre of which 0.011 Acre has been dedicated for highway purposes. 0.005 Acre being out of Deed OR 527, page 362 and 0.298 Acre being out of Deed OR 485, page 662. The above-described tract of land is subject to all legal easements, restrictions and reservations, if any, of record or in use on said premises. Previous deed reference: Volume OR 527, page 362 and Volume OR 485, page 662. The above description and plat are recorded in Survey Book "P", Page 769, in the Auglaize County Engineer's Office. Basis of bearing is holding the South line of the Southeast Quarter of Section 14 and the centerline of County Road 110 as N.89°52'04"W. per the Auglaize County Global Positioning Survey.
