

OTT / REIER DESCRIPTION 0.152 ACRE TRACT

Commencing at a Monument Box found at the Southeast corner of the Northwest Quarter of Section 20, Moulton Township and in the centerline of County Road 166 (Doering Road);

Thence N.89°30'57"W. along the centerline of County Road 166 and the South line of the Northwest Quarter of said Section 22, a distance of 1,325.08 feet to a Mag Nail set, which is the PLACE OF BEGINNING for the tract of land herein described;

Thence continuing N.89°30'57"W. along the above described line, a distance of 10.00 feet to a Mag Nail set;

Thence N.00°51'34"E. a distance of 1,322,15 feet to an existing 6-inch steel end post set in concrete, passing thru an iron pin set for reference at 25.00 feet in the North right-of-way line of County Road 166;

Thence S.00°25'34"W. a distance of 1,322.12 feet to the Mag Nail in the centerline of County Road 166, said Mag nail was the true PLACE OF BEGINNING.



Thence N.00°51'34"E. a distance of 651.14 feet to an iron pin set, passing thru an iron pin set for reference at 25.00 feet in the North right-of-way line of County Road 166;
