

## JOHNS DESCRIPTION 62.255 ACRES

The following described tract of land is part of the Northwest Quarter of Section 12, Town 6 South, Range 4 East, St. Marys Township, Auglaize County, Ohio and is more particularly described as follows:

Commencing at a monument box located at the Northwest corner of the Northwest Quarter of Section 12, St. Marys Township and in the centerline of County Road 61 (Plattner Pike);

Thence S.01°15'19"W. along the West line of the Northwest Quarter of Section 12, St. Marys Township and the centerline of County Road 61 (Plattner Road), a distance of 350.00 feet to an R.R. Spike found, which is the PLACE OF BEGINNING for the tract of land herein described;

Thence S.88°44'41"E. a distance of 234.01 feet to an iron pin set, passing thru an iron pin found at 38.34 feet in the East right-of-way line of County Road 61;

Thence N.01°15'19"E. a distance of 353.01 feet to a point, being referenced by an iron pin found at 0.46 feet North of said point;

Thence S.89°28'50"E. along the North line of the Northwest Quarter of Section 12, a distance of 1,095.41 feet to a point being referenced by an O.D.O.T. R/W monument found at S.01°33'51"W, 56.89 feet;

Thence S.01°33'51"W. a distance of 123.93 feet to a Mag Nail set in the centerline of State Route 29, passing thru an O.D.O.T. R/W monument at 56.89 feet;

Thence S.86°28'07"W. along the centerline of State Route 29, a distance of 390.51 feet to a Mag Nail set;

Thence S.00°37'57"W. a distance of 200.99 feet to an iron pin set, passing thru an iron pin set at 52.24 feet in the South right-of-way line of State Route 29;

Thence N.86°28'07"E. a distance of 130.04 feet to an iron pin found;

Thence N.87°41'56"E. a distance of 258.61 feet to an iron pin found;

Thence S.01°04'47"W. a distance of 2,156,41 feet to a point in the centerline of Center Branch Creek, passing thru an iron pin set for reference at 1,846.86 feet;

Thence N.76°58'36"W., along the centerline of Center Branch Creek, a distance of 148.06 feet to a point;

Thence N.53°43'41"W., along the centerline of Center Branch Creek, a distance of 98.36 feet to a point;

Thence N.52°38'07"W., along the centerline of Center Branch Creek, a distance of 85.24 feet to a point;

Thence N.64°31'53"W., along the centerline of Center Branch Creek, a distance of 110.04 feet to a point;

Thence N.58°30'38"W., along the centerline of Center Branch Creek, a distance of 294.99 feet to a point;

Thence N.64°00'55"W., along the centerline of Center Branch Creek, a distance of 259.11 feet to a point;

Thence N.66°49'53"W., along the centerline of Center Branch Creek, a distance of 396.52 feet to a point;

Thence N.30°25'37"W., along the centerline of Center Branch Creek, a distance of 93.36 feet to a point;

Thence N.59°10'04"W., along the centerline of Center Branch Creek, a distance of 39.27 feet to a Mag Nail set in the centerline of County Road 61;

Thence N.01°15'19"E. along the centerline of County Road 61 and the West line of the Northwest Quarter of Section 12, St. Marys Township a distance of 1,434.18 feet to a R.R. Spike found which was the true PLACE OF BEGINNING.

Containing in all 62.255 Acre of which 4.521Acre is subject to highway right-of-way purposes. The above-described tract of land is subject to all legal easements, restrictions and reservations, if any, of record or in use on said premises. Previous deed reference: Volume OR 343, page 150.
