



SURVEYOR'S DESCRIPTION

Being a part of the northwest fractional quarter of Section 27, Town-5-South, Range-4-East, Noble Township, Auglaize County, Ohio as evidenced by Official Record Volume 196, Page 781 and more particularly described as follows:

Commencing for reference at a monument box (found) at the west quarter corner of Section 27 and the legal centerline of St. Marys River Road; thence, N 00° 06′ 37″ E along the west line of the northwest fractional quarter of Section 27 and the aforesaid legal centerline, for a distance of 1202.34 feet to a mag-nail (set), said nail being the **POINT OF BEGINNING**;

thence, continuing N 00° 06′ 37″ E along the aforesaid west line and legal centerline for a distance of 171.51 feet to a cotton gin spindle (found);

thence, N 89° 58′ 31″ E (passing through a 5/8″ re-rod w/cap found on the east right-of-way line of S. Marys River Road at a distance of 25.00 feet) for a total distance of 526.20 feet to a 5/8″ re-rod w/cap (found);

thence, N 07° 14′ 50″ W for a distance of 423.36 feet to a 5/8″ rerod w/cap (found);

thence, N 06° 36′ 22″ E for a distance of 211.41 feet to a 5/8″ rerod w/cap (set);

thence, N 89° 58′ 31″ E for a distance of 110.45 feet to a point in the centerline of the St. Marys River;

thence, along the centerline of said St. Marys River with the following courses;

N 68° 06′ 33″ E for a distance of 84.10 feet;
N 82° 45′ 16″ E for a distance of 117.05 feet;
S 54° 35′ 34″ E for a distance of 94.92 feet;
S 32° 22′ 52″ E for a distance of 181.69 feet;
S 37° 48′ 26″ E for a distance of 104.67 feet;
S 32° 51′ 30″ E for a distance of 120.44 feet;
S 45° 20′ 33″ E for a distance of 193.27 feet;
S 22° 47′ 18″ E for a distance of 87.24 feet;

thence, leaving the centerline of the St. Marys River on a bearing of S00° 07′ 14″ W (passing through a 4″ diameter steel post at a

distance of 32.21 feet) for a total distance of 431.10 feet to a 5/8" rerod (found);

thence, S 89° 59′ 27″ W for a distance of 913.12 feet to a 5/8″ rerod w/cap (found);

thence, N 00° 06′ 37″ E for a distance of 208.71 feet to a 5/8″ rerod w/cap (found);

thence, S 89° 59′ 27″ W (passing through the east right-of-way line of St. Marys River Road at a distance of 392.46 feet) for a total distance of 417.43 feet to the **POINT OF BEGINNING**, containing therein **18.966 acres**, of which 0.098 acres is road right-of-way. Subject to all easements and highways of record at the time of the recording of this instrument. Prepared by James M.
