SURVEYOR'S DESCRIPTION FOR 3.01 ACRES BEING A PART OF THE SOUTHWEST QUARTER OF SECTION 33, DUCHOUQUET TOWNSHIP, T-4-S, R-6-E, AUGLAIZE COUNTY, OHIO

The following described parcel of land is situated in the Southwest Quarter of Section 33, Duchouquet Township, Town-4-South, Range-6-East, Auglaize County, Ohio, and is more further described as follows:

Commencing for reference at a Monument Box situated at the Northwest Corner of the Southwest Quarter of said Section 33, Duchouquet Township;

Thence with a bearing of S. 00° -51'-28" W. along the West line of the Southwest Quarter of said Section 33, Duchouquet Township, and the centerline of Wapak-Cridersville Road (C.R. #151), for a distance of 2,013.00 feet to a Mag Nail (set) and the PLACE OF BEGINNING;

Thence with a bearing of $5.89^{\circ}-29'-16''$ E. for a distance of 397.51 feet to an Iron Pin (set), and passing thru an Iron Pin (set) for reference at a distance of 30.00 feet;

Thence with a bearing of S. 00°-51'-28" W. and parallel with the West line of the Southwest Quarter of said Section 33, Duchouquet Township, and the centerline of Wapak-Cridersville Road (C.R. #151), for a distance of 320.04 feet to an Iron Pin (set);

Thence with a bearing of S. 87°-13-14" W. for a distance of 195.36 feet to a 6" Wood End Post (found);

Thence with a bearing of S. 89°-01-28" W. for a distance of 202.64 feet to a Mag Nail (set) over a Railroad Spike (found), and passing thru a Wood End Post (found) for reference at a distance of 174.64 feet

Thence with a bearing of N. 00°-51-28" E. along the West line of the Southwest Quarter of said Section 33, Duchouquet Township, and the centerline of Wapak-Cridersville Road (C.R. #151), for a distance of 336.52 feet to a Mag Nail (set) and the original PLACE OF BEGINNING.

The above described parcel of land contains in all 3.010 Acres, of which, 0.23 Acre being previously dedicated for highway purposes. The above described parcel of land is subject to all legal easements, reservations, and restrictions of public record.
