

# REINEKE SURVEY DESCRIPTION PARCEL 1

Being a parcel of land situated in Saint Marys Township, Auglaize County, Ohio, and part of lot number 19 and all of lot number 20 of Sandy Beach Allotment Section H in Section 6, Township 6 South, Range 4 East, being more particularly described as follows:

Commencing at an iron pin found at the northeast corner of lot number 20 of Sandy Beach Allotment Section H (Plat Book A, Page 17) being the Point of Beginning;

thence S 00° 00' 44" E, 75.01 feet along the east line of said lot numbers 19 and 20 to an iron pin with cap set;

thence N 89° 25' 46" W, 111.99 feet to an iron pin with cap set;

thence N 00° 00' 00" E, 75.02 feet along the west line of said lot numbers 19 and 20 and also being the east right-of way line of Dickman Road to an iron pin found at the northwest corner of said lot number 20;

thence S 89° 25' 26" E, 111.97 feet along the north line of said lot number 20 to the Point of Beginning, containing 8,399.49 square feet of land more or less, subject to all valid easements and right-of-way.

### REINEKE SURVEY DESCRIPTION PARCEL 2

Commencing at an iron pin found at the northeast corner of lot number 20 of Sandy Beach Allotment Section H (Plat Book A, Page 17);

thence S 00° 00' 44" E, 75.01 feet along the east line of said lot numbers 19 and 20 to an iron pin with cap set as the Point of Beginning;

thence continuing S 00° 00' 44" E, 75.01 feet along the east line of said lot numbers 18 and 19 to an iron pin with cap set at the southeast corner of said lot number 18;

thence N 89° 26' 07" W, 112.00 feet along the south line of said lot number 18 to an iron pin with cap set;

thence N 00° 00' 00" E, 75.02 feet along the west line of said lot numbers 18 and 19 and also being the east right-of way line of Dickman Road to an iron pin with cap set;

thence S 89° 25' 46" E, 111.99 feet to the Point of Beginning, containing 8,400.69 square feet of land more or less, subject to all valid easements and right-of-way.
