SURVEYOR'S DESCRIPTION

Being a part of the southwest quarter of Section 19, Town-5-South, Range-8-East, Wayne Township, Auglaize County, Ohio as evidenced by Official Record Volume 565, Page 610 and more particularly described as follows:

Commencing for reference at a monument box (found) at the southeast corner of Section 19, and the centerline intersection of Waynesfield Road and Blank Pike; thence, N 89° 16′ 35″ W along the south line of Section 19 and the legal centerline of Blank Pike, for a distance of 4486.90 feet to a mag-nail (found), said nail being the **POINT OF BEGINNING** for the parcel herein described;

Thence, continuing along the aforesaid south line and legal centerline, N 89° 16′ 35″ W for a distance of 608.79 feet to a monument box (found) at the southwest corner of the southwest quarter of Section 19 and the legal centerline of Santa Fe Line Road;

Thence, N 00° 55′ 40″ E for a distance of 1038.09 feet to a magnail (set);

Thence, S 89° 12′ 05″ E (passing through a 5/8″ re-rod w/cap set on the east right-of-way line of Santa Fe Line Road at a distance of 25.00 feet) for a total distance of 250.00 feet to a 5/8″ re-rod w/cap (set);

Thence, N 00° 55′ 40″ E for a distance of 283.65 feet to a 5/8″ rerod w/cap (set);

Thence, S 89° 13′ 18″ E for a distance of 363.74 feet to a 5/8″ rerod w/cap (set);

Thence, S 01° 08′ 33″ W (passing through a 5/8″ re-rod w/cap (found) on the north right-of-way line of Blank Pike at a distance of 1296.09 feet) for a total distance of 1321.09 feet to the **POINT OF BEGINNING**, containing therein **16.914 acres**, of which 0.931 acres is road right-of-way.
