SURVEYOR'S DESCRIPTION

Being a part of the southwest quarter of Section 22, Town-6-South, Range-4-East, St. Marys Township, Auglaize County, Ohio as evidenced by Official Record Volume 219, Page 1014 and more particularly described as follows:

Commencing for reference at a monument box found on the west quarter corner of Section 22, said quarter corner also being the legal centerline of Dowty Road; thence, \$ 01° 26' 59" W for a distance of 725.85 feet to a 5/8" rerod w/cap (found); thence, \$ 87° 50' 38" E for a distance of 618.90 feet to a 5/8" re-rod w/cap (set), said re-rod being the **POINT OF BEGINNING** for the tract herein described;

thence, N 02° 10' 23" E for a distance of 269.16 feet to a 5/8" re-rod w/cap (set);

thence, \$ 88° 58' 29" E (passing through a 5/8" re-rod w/cap set on the west right-of-way line of County Road 66-A at a distance of 301.67 feet) for a total distance of 328.92 feet to a mag-nail (set) on the centerline of County Road 66-A):

thence, \$ 24° 28' 56" W along the aforesaid centerline for a distance of 74.40 feet to a mag-nail (set) on a point of curve;

thence, continuing along the aforesaid centerline on a tangent curve to the left, said curve having a central angle which measures 05° 18' 14"; a radius which measures 450.00 feet; a chord which bear \$ 21° 49' 49" W and a chord which measures 41.64 feet, for a total arc length which measures 41.66 feet to a mag-nail set at a point of reverse curve;

thence, continuing along the aforesaid centerline on a tangent curve to the right, said curve having a central angle which measures 24° 39' 53"; a radius which measures 448.25 feet; a chord which bears \$ 31° 30' 39" W and a chord which measures 191.48 feet, for a total arc length which measures 192.96 feet to a mag-nail (set);

thence, N 88° 47' 00" W for a distance of 44.09 feet to a 5/8" re-rod w/cap (found) on the west right-of-way line of County Road 66-A;

thence, N 87° 50' 38" W for a distance of 148.71 feet to the **POINT OF BEGINNING**, containing therein **1.688 acres** of which 0.180 acres is road right-of-way. Commencing for reference at a monument box found on the north line of the southwest quarter of Section 22 and the legal centerline intersection of Dowty Road and County Road 66-A; thence, N 88° 17' 26"W along the aforesaid north line and legal centerline of Dowty Road for a distance of 586.79 feet to a magnail (set), said nail being the POINT OF BEGINNING for the tract herein described;

thence, \$ 01° 46' 34" W (passing through a 5/8" re-rod w/cap set on the south right-of-way line of Dowty Road at a distance of 25.00 feet) for a total distance of 181.57 feet to a 5/8" re-rod w/cap (set);

thence, \$ 88° 18' 08" E (passing through a 5/8" re-rod w/cap set on the west right-of-way line of CR 66-A at a distance of 423.26 feet) for a total distance of 454.03 feet to a mag-nail (set) on the centerline of CR 66-A;

thence, with the centerline of CR 66-A on a non-tangent curve which is concave to the southeast, said curve having a central angle which measures 11° 02' 30", a radius which measures 1056.50 feet, a chord which bears \$ 31° 12' 41" W and a chord which measures 203.29 feet, for a total arc length of 203.60 feet to a mag-nail (set);

thence, continuing along the aforesaid centerline, \$ 24° 28' 56" W for a distance of 107.57 feet to a mag-nail (set);

thence, N 88° 58' 29" W (passing through a 5/8" re-rod w/cap set on the west right-of-way line of CR 66-A at a distance of 27.25 feet) for a total distance of 328.92 feet to a 5/8" re-rod w/cap (set);

thence, S 02° 10' 23" W for a distance of 269.16 feet to a 5/8" re-rod w/cap (set);

Commencing for reference at a monument box found on the west quarter corner of Section 22, said quarter corner also being the legal centerline of Dowty Road; thence, \$ 01° 26' 59" W for a distance of 725.85 feet to a 5/8" re-rod w/cap (found); thence, \$ 87° 50' 38" E for a distance of 767.61 feet to a 5/8" re-rod w/cap (found) on the west right-of-way line of County Road 66-A; thence, S 88° 47' 00" E for a distance of 44.09 feet to a mag-nail (set) on the centerline of County Road 66-A, said nail being the POINT OF BEGINNING for the tract herein described;

thence, along the centerline of CR 66-A on a non-tangent curve which is concave to the northwest, said curve having a central angle which measures 24° 39' 53", a radius which measures 448.25 feet, a chord which bears N 31° 30' 39" E and a chord which measures 191.48 feet for a total arc length of 192.96 feet to a mag-nail set at a point of reverse curve;

thence, continuing along the aforesaid centerline on a tangent curve to the right, said curve having a central angle which measures 05° 18' 14", a radius which measures 450.00 feet, a chord which bears N 21° 49' 49" E and a chord which measures 41.64 feet for a total arc length of 41.66 feet to a mag-nail (set);

thence, continuing along the aforesaid centerline, N 24° 28′ 56″ E for a distance of 181.97 feet to a mag-nail (set) on a point of curve;

thence, continuing along the aforesaid centerline on a non-tangent curve to the right, said curve having a central angle which measures 11° 02' 30", a radius which measures 1056.50 feet, a chord which bears N 31° 12' 41" E and a chord which measures 203.29 feet, for a total arc length of 203.60 feet to a mag-nail set;

thence, continuing along the aforesaid centerline N 37° 56' 27" E for a distance of 224.98 feet to a monument box found on the north line of the southwest quarter of Section 22 and the centerline intersection of CR 66-A and Dowty Road;

thence, leaving the centerline of CR 66-A, on the north line of the southwest quarter of Section 22, \$ 88° 17' 26" E (passing through a 5/8" re-rod w/cap set on the east rightof-way line of CR 66-A at a distance of 30.99 feet) for a total distance of 59.61 feet to a 5/8" re-rod w/cap (found) on the west line of the West Ohio Rail Authority Railroad;

thence, S 01° 46′ 36" W along the aforesaid west line, for a distance of 727.39 feet to a point (said point referenced by a 5/8" re-rod w/cap set bearing N 78° 01' 10" E of and 0.80 feet from said corner;

thence, N 88° 47' 00" W (passing through a 5/8" re-rod w/cap set on the east right-ofway line of CR 66-A at a distance of 427.69 feet) for a total distance of 471.78 feet to the POINT OF BEGINNING, containing therein 4.684 acres of which 0.482 acres is road rightof-way.
