

SANFORD SURVEY DESCRIPTION

Being part of lot numbers 3 and 4 of Howard Parker Subdivision and also being part of the northwest quarter of the southeast quarter of Section 4, St. Marys Township, Township 6 South, Range 4 East, Auglaize County, Ohio, being more particularly described as follows:

Commencing at an iron pin found at the southwest corner of lot number 3 of Howard Parker Subdivision;

thence S 88° 30' 40" E, 65.00 feet along the south line of said lot number 3 to a point;

thence N 01° 25' 56" E, 57.40 feet along the east line of said lot number 3 and also being the west right-of-way line of Parker Street to a Mag nail set as the Point of Beginning;

thence N 88° 52' 43" W, 126.00 feet to an iron pin with cap set;

thence N 01° 25' 56" E, 75.00 feet to an iron pin with cap set;

thence S 89° 16' 12" E, 61.00 feet to an iron pin found;

thence S 88° 30' 40" E, 65.00 feet to a P.K. nail found;

thence S 01° 25' 56" W, 75.00 feet along the east line of said lot numbers 3 & 4 and also being the west right-of-way line of Parker Street to the Point of Beginning, containing 9,475.91 square feet of land more or less, subject to all valid easements and right-of-way.

All bearings were calculated from angles turned in an actual field survey by Kent B. Marbaugh, Registered Surveyor #7421, dated May 19, 2009, on file in the County Tax Map Office.
