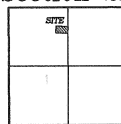


Corner Post at

County, Ohio.

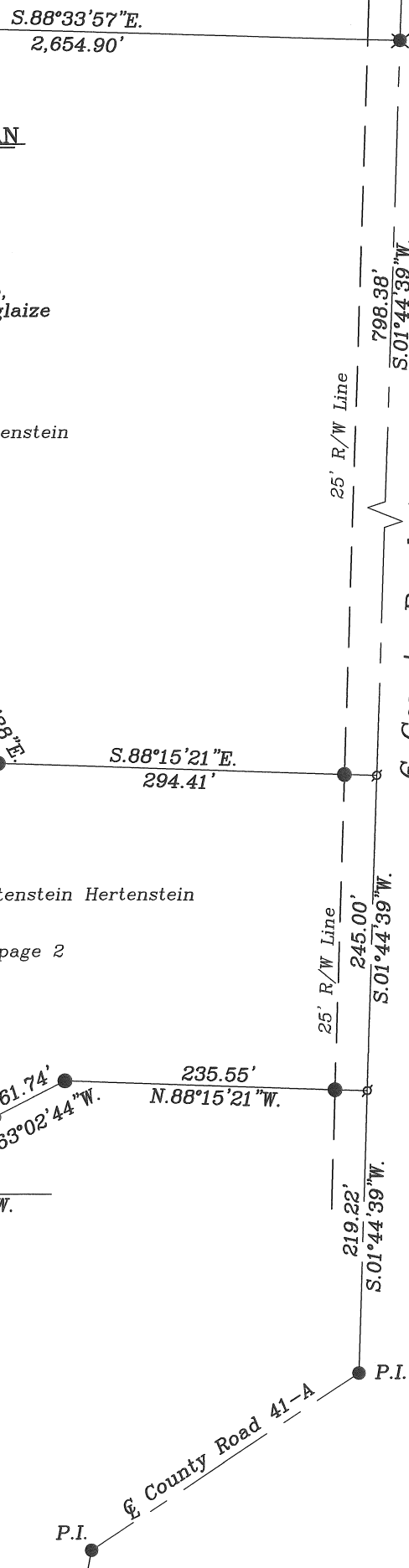
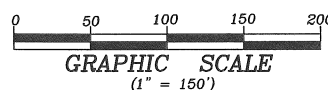

HERTENSTEIN SURVEY

Commencing at a Corner Post found at the Northwest corner of the Northwest
Quarter of Section 22, Noble Township;
thence S.88°33'57"E. along the North line of the Northwest Quarter of Section 22,
a distance of 2,654.90 feet to a P.K. Nail found;
thence S.01°44'39"W. along the centerline of County Road 41-A (St. Marys River Road)
a distance of 798.38 feet to a Mag Nail found;
thence N.88°15'21"W. a distance of 294.41 feet to an iron pin found, passing thru an
iron pin found at 25.00 in the West right-of-way line of County Road 41-A;
thence N.31°47'38"W. a distance of 85.07 feet to an iron pin found;
thence N.52°05'02"W. a distance of 139.74 feet to an iron pin found;
thence S.85°22'12"W. a distance of 144.47 feet to an iron pin set, which is the PLACE
OF BEGINNING for the tract of land herein described;
thence continuing S.85°22'12"W. a distance of 67.94 feet to an iron pin found;
thence S.61°29'59"W. a distance of 55.21 feet to an iron pin found;
thence S.15°19'31"W. a distance of 84.74 feet to an iron pin found;
thence S.29°23'52"E. a distance of 98.51 feet to an iron pin found;
thence S.51°02'38"E. a distance of 340.99 feet to an iron pin found;
thence S.25°16'59"W. a distance of 17.00 feet to an iron pin set;
thence N.58°21'14"W. a distance of 487.00 feet to an iron pin set;
thence N.09°20'49"E. a distance of 526.94 feet to an iron pin set;
thence S.67°57'07"E. a distance of 209.75 feet to an iron pin set;
thence S.07°02'12"W. a distance of 269.61 feet to the iron pin which was the true
PLACE OF BEGINNING.
