SCHMIESING SURVEY 17.967 ACRES

SITUATE IN THE NORTHEAST QUARTER OF SECTION 17 TOWN 7S RANGE 4E, GERMAN TOWNSHIP, AUGLAIZE COUNTY OHIO, AND BEING PART OF THOSE LANDS OWNED BY YOLANDA SCHMIESING AS RECORDED IN OFFICIAL RECORD 532 PAGE 2237 AND BEING MORE PARTICULLARY DESCRIBED AS FOLLOWS:

Beginning for reference at railroad spike found at the northwest corner of the northeast quarter of Section 17 and being in the centerline of State Route 274;

Thence, with the north line of the northeast quarter of Section 17 and the centerline of State Route 274, South 88°27'50" East, 21.00 feet to a Mag Spike set, said Mag Spike being the **True Point of Beginning** of the tract herein described;

Thence, continuing with the previous lines, South 88°27'50" East, 855.11 feet to a Mag Spike set;

Thence, with new division lines and generally along the centerline of Vondenhuevel Creek the following 12 courses;

- 1. South 48°07'11" West, 47.80 feet, witness at North 07°09'21" West, 15.00 feet an iron pin set;
- 2. South 82°50'39" West, 43.81 feet, witness at North 23°27'35" West, 15.00 feet an iron pin set;
- 3. South 66°27'01" West, 36.48 feet to a point in the south right of way line of State Route 274, witness at North 65°32'23" West, 25.00 feet an iron pin set;
- 4. South 24°27'37" West, 31.46 feet, witness at North 83°30'04" West, 25.00 feet an iron pin set;
- 5. South 06°29'56" West, 386.57 feet, witness at North 72°38'06" West, 35.00 feet an iron pin set;
- 6. South 17°21'54" West, 152.80 feet, witness at North 60°41'17" West, 35.00 feet an iron pin set;
- 7. South 29°18'43" West, 192.15 feet, witness at North 58°35'15" West, 35.00 feet an iron pin set;
- 8. South 31°24'45" West, 212.54 feet, witness at North 75°09'10" West, 30.00 feet an iron pin set;
- 9. South 14°50'50" West, 73.33 feet, witness at North 85°10'56" West, 30.00 feet an iron pin set;
- 10. South 04°49'04" West, 97.38 feet, witness at North 63°56'22" West, 40.00 feet an iron pin set;
- 11. South 26°03'38" West, 75.16 feet, witness at North 79°23'33" West, 30.00 feet an iron pin set;
- 12. South 10°36'27" West, 126.45 feet to the north line of a 100.00 acre tract of land owned by L. & E. Schwartz as recorded in Official Record 402 Page 227.

Thence, with the north line of said 100.00 acre tract, North 88°33'12" West, 371.09 feet to an iron pin set in the west line of said 100.00 acre tract, passing for reference at 40.00 feet an iron pin set;

Thence, with the west line of said 100.00 acre tract, North 00°49'25" East, 1332.85 feet to the **True Point of Beginning**, passing for reference at 1302.85 feet an iron pin set in the south right of way line of State Route 274 and containing 17.967 acres more or less of which 0.657 acres lie within the right of way of State Route 274 and being subject to all legal rights of way, easements, agreements and restrictions of record.
