SCHWARTZ SURVEY 1.335 ACRES

SITUATE IN THE NORTHWEST QUARTER OF SECTION 17 TOWN 7S RANGE 4E, GERMAN TOWNSHIP, AUGLAIZE COUNTY OHIO, AND BEING PART OF THOSE LANDS OWNED BY LEO AND ESTHER SCHWARTZ (TRUSTEES) AS RECORDED IN OFFICIAL RECORD 402 PAGE 227 AND BEING MORE PARTICULLARY DESCRIBED AS FOLLOWS:

Beginning for reference at a harrow tooth found at the southwest corner of the northwest quarter of Section 17 and being in the centerline of State Route 364;

Thence, with the west line of the northwest quarter of Section 17 and the centerline of State Route 364, North 00°41'05" East, 150.00 feet to a Mag Nail set, said Mag Nail being the **True Point of Beginning** of the tract herein described;

Thence, continuing with the previous lines, North 00°41'05" East, 200.00 feet to a Mag Nail set;

Thence, with new division line, South 88°35'59" East, 290.62 feet to a iron pin set, passing for reference at 30.00 feet the east right of way line of State Route 364 and 31.00 feet a iron pin set;

Thence, with the east line of Tract #2 and Tract #3 filed in Survey Book "B" Page 23, South 00°43'43" West, 200.22 feet to a 5/8 inch iron pin found, passing for reference at 50.00 feet a 5/8 inch iron pin found at the northeast corner of said Tract #3;

Thence, with the north line of a 1.000 acre tract referenced as Tract #4 in Survey Book "B" Page 23 and being owned by R. & E. Schwartz as recorded in Official Record 551, Page 1860, North 88°33'23" West, 290.47 feet to the **True Point of Beginning**, passing for reference at 259.47 feet an iron pin set and at 260.47 feet the east right of way line of State Route 364 and containing 1.335 acres more or less of which 0.138 acres lie within the right of way of State Route 364 and being subject to all legal rights of way, easements, agreements and restrictions of record.

Bearings listed above are based on the north line of the northwest quarter of Section 17 and the centerline of State Route 274 being South 88°28'23" East as per Survey Book "Q", Page 358 filed in the Auglaize County Tax Map Office. The deed records referenced are all recorded in the Auglaize County Recorder's Office. Pins noted as set are 5/8" x 30" rebar with orange plastic caps stamped "Lock-Two 7988".
