

PLACE OF BEGINNING is the northeast corner of lot 1879, of Waldman's Sub-division as recorded in plat book 2 page 99, in the Auglaize County Recorder's office, said point being the center of the north side of an 4 inch square concrete post;

Thence N.89°34'34"W., along the north line of said lot 1877, a distance of 166.40 feet to an iron pin found on the northeasterly right-of-way of Defiance Street;

Thence N.34°48'21"W., along the northeasterly right-of-way of Defiance Street (sixty feet wide right-of-way), a distance of 73.42 feet to an iron pin found;

Thence S.89°34'34"E., a distance of 206.98 feet to an iron pin found;

Thence S.01°16'07"E., a distance of 60.00 feet, to the point, which was the PLACEOF BEGINNING.

Containing 11,196 square feet, more or less, a being subject to all easements, of record, or in use on said premises.

Thence N.89°34'34"W., a distance of 206.98 feet to an iron pin found on the northeasterly right-of-way of Defiance Street;

Thence N.34°48'21"W., along the northeasterly right-of-way of Defiance Street (sixty feet wide right-of-way), a distance of 90.69 feet to a point, reference an iron pin found, S.89°46'29"E 0.65 feet.;

Thence S.89°46'29"E., passing an iron pin found at 0.65 feet, a total distance of 257.08 feet to an iron pin found;

Thence S.01°16'07"E., a distance of 75.00 feet, to the iron pin, which was the PLACE OF BEGINNING.
