



SURVEYOR'S DESCRIPTION

scale:

Being a part of the northeast quarter of Section 21, Town-5-South, Range-6-East, Duchouquet Township, Auglaize County, Ohio as evidenced by O.R. Volume 450, Page 70; all of Parcel No. B05-021-027-00 and a portion of Parcel No. B05-021-026-02 more particularly described as follows:

Commencing for reference at a monument box (found) at the northeast corner of Section 21 and the legal centerline of Hauss Road; thence, S 01° 10′ 46″ W along the east line of the northeast quarter of Section 21 and the legal centerline of Hauss Road, for a distance of 666.37 feet to a point; thence, N 89° 47′ 37″ W passing through the west right-of-way line of Hauss Road at a distance of 20.00 feet) for a total distance of 662.14 feet to a 5/8″ re-rod w/cap (found); thence, S 01° 10′ 35″ W for a distance of 432.38 feet to a 5/8″ re-rod w/cap (found) said re-rod being the **POINT OF BEGINNING** for the tract herein described;

thence, S 79° 52' 45" E for a distance of 373.09 feet to a 5/8" re-rod w/cap (set) in the centerline of a ditch;

thence, S 06° 21' 58" E along the centerline of said ditch for a distance of 90.01 feet to a 5/8" re-rod w/cap (set);

thence, S 17° 16' 58" W along the centerline of said ditch for a distance of 33.84 feet to a 5/8" re-rod w/cap (set);

thence, S 89° 24' 10" E (passing through a 5/8" re-rod w/cap set at a distance of 171.63 feet) for a total distance of 216.58 feet to a p-k nail (set) in the centerline of County Road 25-A;

thence, S 27° 49' 00" W along the centerline of CR 25-A for a distance of 56.22 feet to a p-k nail (set) on the south line of the northeast quarter of the northeast quarter of Section 21;

thence, N 89° 24' 10" W along the south line of the northeast quarter of the northeast quarter of Section 21 for a distance of 659.76 feet to a 5/8" re-rod w/cap (set);

thence, N 01° 10' 35" E for a distance of 233.50 feet to a 5/8" re-rod w/cap (set);

thence, S 89° 24' 10" E for a distance of 97.39 feet to the **POINT OF BEGINNING** containing therein **2.491 acres**, of which 0.052 acres is road right-of-way. Subject to all easements and right-of-way of record at the time of the recording of this instrument.

Thence, N 89° 24' 10" W for a distance of 564.71 feet to a 5/8" re-rod w/cap (found);

Thence, N 01° 10' 24" E for a distance of 665.38 feet to a 5/8" re-rod w/cap (set);

Thence, S 89° 26' 46" E for a distance of 662.14 feet to the **POINT OF BEGINNING** containing therein **9.596 acres**.
