

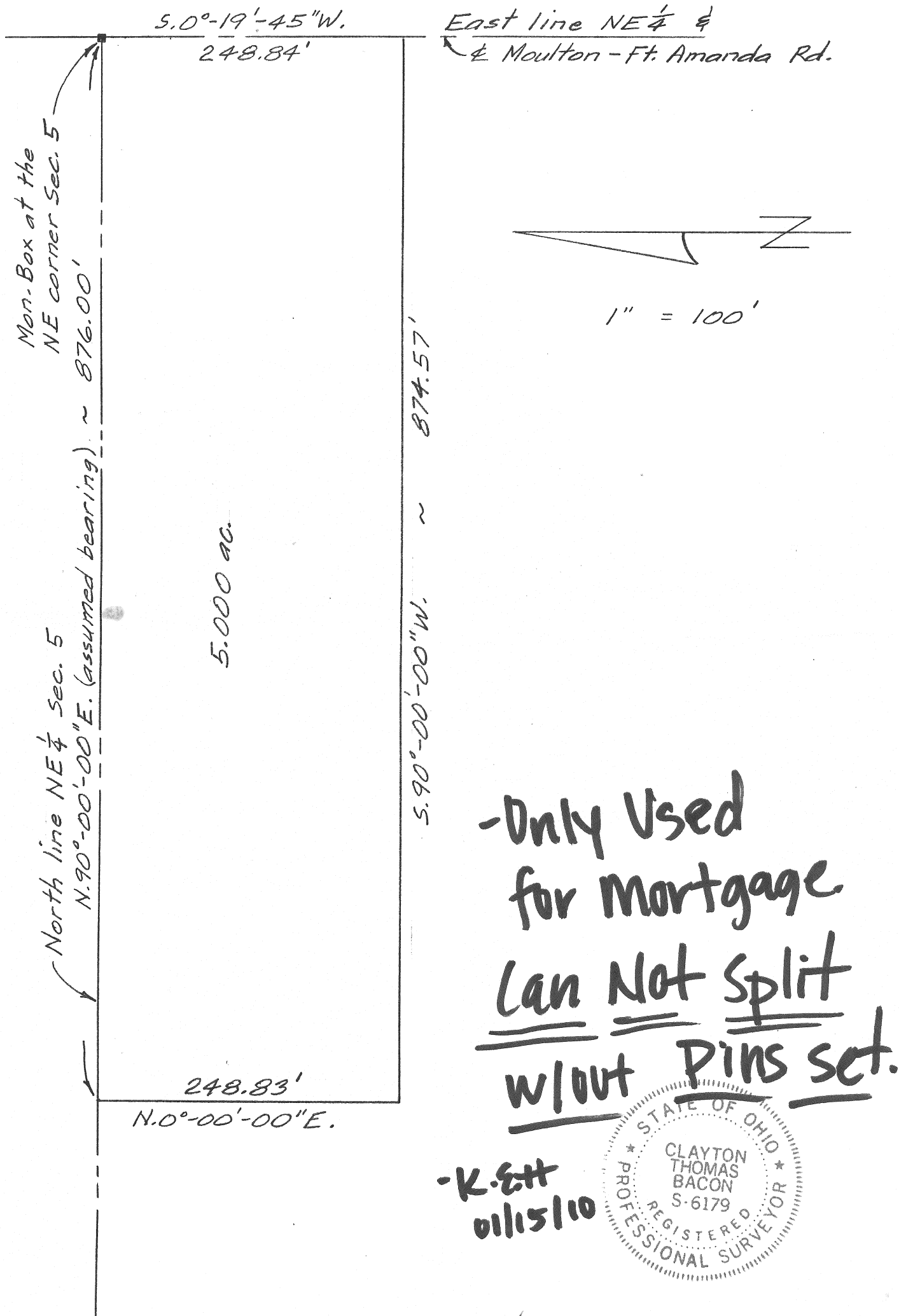

EXHIBIT "A"

Being a parcel of land in the NE $\frac{1}{4}$ of Section 5, T5S, R5E, Logan Township, Auglaize County, Ohio, more particularly described as follows:

Beginning at a monument box at the northeast corner of Section 5, thence the following courses;

1. S.0 $^{\circ}$ -19'-45"W. (assumed bearing) on the east line of the NE $\frac{1}{4}$ of Section 5 (being also the centerline of Moulton-Ft. Amanda Rd.), 749.11' to a set RR spike;
2. S.89 $^{\circ}$ -54'-04"W., 1320.66' to a steel fence corner post;
3. S.0 $^{\circ}$ -16'-36"W., 460.50' to the centerline of a ditch, passing over a set #5 rebar at 430.50';
4. N.50 $^{\circ}$ -29'-27"W. on the ditch centerline, 243.44';
5. N.21 $^{\circ}$ -02'-49"W. on the ditch centerline, 176.54';
6. N.15 $^{\circ}$ -23'-23"E. on the ditch centerline, 173.34';
7. N.7 $^{\circ}$ -11'-47"W. on the ditch centerline, 730.88' to the north line of Section 5;
8. N.90 $^{\circ}$ -00'-00"E. on said north Section line, 1623.96' to the POINT OF BEGINNING, passing over a set #5 rebar at 32.00'.

The above described parcel contains 29.051 acres, more or less, subject to all legal highways and easements of record.

2. S.90 $^{\circ}$ -00'-00"W., 874.57';
3. N.0 $^{\circ}$ -00'-00"E., 248.83' to the north line of the NE $\frac{1}{4}$ of Sec. 5;
4. N.90 $^{\circ}$ -00'-00"E. on said north line, 876.00' to the POINT OF BEGINNING.

The above described parcel contains 5.000 acres, more or less, subject to all legal highways and easements of record.
