
Commencing for reference at a 5/8" re-rod w/cap(set) at the northeast corner of Lot 15 of Sherwood Forest; thence S 00° 00' 00" W along the east line of Sherwood Forest Subdivision for a distance of 134.56 feet to a 5/8" re-rod w/cap (set 10" above grade), said re-rod being the POINT OF BEGINNING for the parcel herein described;

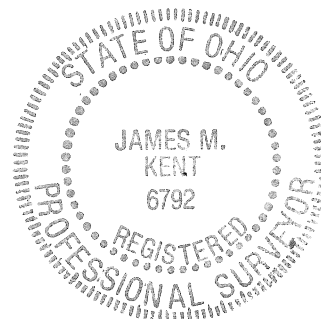
Thence, continuing along the aforesaid east line, S 00° 00' 00" W for a distance of 95.44 feet to a 5/8" re-rod w/cap (set) at the southeast corner of Lot 16;

Thence, S 89° 24' 44" W along the south line of Lot 16 for a distance of 200.50 feet to a 5/8" re-rod w/cap (set) at the southwest corner of Lot 16;

Thence, N 00° 00' 00" E along the west line of Lot 16 and the east right-of-way line of Nottingham Drive for a distance of 95.44 feet to a 5/8" re-rod w/cap (set);

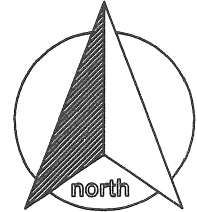



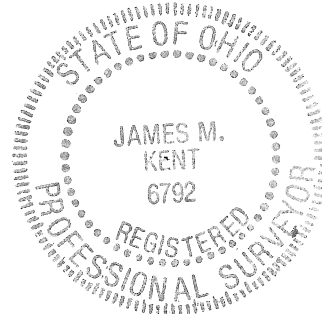
