1.639 ACRE PARCEL

Situated as being part of the Southwest Quarter of Section 8, Township 5 South, Range 8 East, Wayne Township, Auglaize County, Ohio, also being all of a 1.639 tract of land as recorded in Official Record Volume 589, Page 1372 and more particularly described as follows:

Commencing at a Railroad spike found marking the intersecting centerlines of State Route 196 and Fairmount Road #180 and the Southwest corner of the Northwest Quarter of Section 9;

Thence North 90°00'00" East along the South line of the Southwest Quarter of Section 8 (also being the centerline of Fairmount Road #180 - 60 foot right-of-way) a distance of 885.63 feet to a Railroad spike found marking the Southwest corner of said 1.639 acre tract and the POINT of BEGINNING;

Thence along the perimeter of said 1.639 acre tract the following four (4) courses:

North 00°00'00" East along the East line of a 1.333 acre tract of land as recorded in Official Record Volume 576, Page 1908 of the Auglaize County Deed Records a distance of 230.00 feet to a point referenced by a 5/8 inch rebar with ID cap found 0.47 West of said point and passing a point at 30.00 feet referenced by a 5/8 inch rebar with ID cap found 0.19 feet West of said point;

North 90°00'00" East along the South line of a 25.071 acre tract of land as recorded in Official Record Volume 580, Page 1206 of the Auglaize County Deed Records a distance of 310.47 feet to a 5/8 inch rebar with ID cap found;

South 00°00'00" West along the West line of a 0.660 acre tract of land as recorded in Official Record Volume 374, Page 255 of the Auglaize County Deed Records a distance of 230.00 feet to a P.K. nail found on the South line of the Southwest Quarter of Section 8, passing a 5/8 inch rebar with ID cap found at 200.00 feet;

South 90°00'00" West along said South line (centerline of Fairmount Road #180) a distance of 310.47 feet to the POINT OF BEGINNING, said parcel containing 1.639 acres of land, more or less, of which 0.214 acres lies within the right-of-way of Fairmount Road #180 (60 foot right-of-way).

Subject to all legal highways, easements, and restrictions of use whether apparent and/or of record and is from an actual field survey performed in April, 2010, under the supervision of Ohio Professional Surveyor Gregory A. Bockrath, Ohio Surveyor No. 8306.

Note: The bearings used in this description are on an assumed meridian assuming the South line of the Southwest Quarter of Section 8 (also being the centerline of Fairmount Road) to be South 90 degrees 00 minutes 00 seconds West and are for the purpose of angle determination only.
