Beginning for reference at an iron pin in a monument box found at the northwest corner of the southwest quarter of Section 33 and being in the centerline of Moulton - Ft. Amanda Road;

Thence, with the centerline of Moulton – Ft. Amanda Road, South 01°53'05" West, 333.03 feet to a Mag Spike set, said Mag Spike marking the **True Point of Beginning** of the tract herein described;

Thence, with the south line of a 13.5 acre tract of land owned by R. Wysong as recorded in Official Record 520 Page 640, South 88°54'26" East, 1331.63 feet to an iron pin set passing for reference at 5.76 feet the west line of the southwest quarter of Section 33, at 25.00 feet the east right of way line of Moulton – Ft. Amanda Road, at 27.04 feet an iron pin with "Morrisey" cap found and at1327.72 feet an iron pin with "Morrisey" cap found;

Thence, with the east line of said 13.5 acre tract of land, North 00°54'01" East, 332.85 feet to an iron pin set in the north line of the southwest quarter of Section 33 and the south line of a 85.8 acre tract of land owned by R. & J. Fourman (Trustees) as recorded in Official Record 535 Page 1170 witnessing at South 57°49'35" West, 3.37 feet a 5\8 inch iron pin found;

Thence, with the north line of the southwest quarter of Section 33 and south line of said 85.8 acre tract, South 88°54'02" East, 597.72 to an iron pin set;

Thence, with a new division line South 00°54'05" West, 1333.92 feet to an iron pin set in the north line of a 47 acre tract of land owned by R. Boop as recorded in Deed Volume 256 Page 629;

Thence, lines of said 47 acre tract the following 5 courses:

- 5. North 88°36'44" West, 292.04 feet to an iron pin found with "Jauert" cap;

Thence, with the east line of a 1.115 acre tract owned by M. Gibson as recorded in Official Record 494 Page 405, North 01°17'33" East, 200.00 feet to bent 5\8 inch iron pin found;

Thence, with the north line of said 1.115 acre tract, North 88°35'50" West, 247.28 feet to a Mag Spike set in the centerline of Moulton – Ft. Amanda Road, passing for reference at 222.28 feet an iron pin set in the east right of way line of Moulton – Ft. Amanda Road and at 237.77 feet the west line of the southwest quarter of Section 33;

Thence, with the centerline of Moulton – Ft. 


